**MINUTES - PUBLIC MEETING NO. 14-03-12**

Subsequent to the reading of a statement of compliance with the notice requirements of the Open Public Meetings Act and identification of items discussed during closed session, the Commission considered and took formal action on the following matters:

1. By a vote of 3-0, ratified the minutes of February 12, 2014 public meeting (transcript page 8).
2. By a vote of 3-0, remanded the initial application of Brian D. Kohler, Sr., for a casino key employee license to a hearing (Exhibit EL-1\*;transcript pages 8-10); and  
  
By a vote of 3-0, remanded the resubmitted application of Sueheidi A. Vega, for a casino key employee license to a hearing (Exhibit EL-1\*;transcript pages 10-11).

By a vote of 3-0, remanded the resubmitted application of Rafael Nieves, for a casino key employee license to a hearing (Exhibit EL-2\*; transcript pages 12-13).

Temporary casino key employee licenses were issued between February 10, 2014 and March 10, 2014, pursuant to Delegation of Authority Resolution Number 13-01-10-16-C to the following applicants: David V. Bartole, Desmon K. Devery, Paula DiMaggio and Barrie R. Feldman (Exhibit EL-4\*; transcript pages 13).
5. By a vote of 3-0, granted the requested relief and inactivated the casino key employee licenses held by Mary L. Diaz, Frank W. Digerolamo, Peter L. Getzler, Steven M. Gietka, Diana M. Guilmartin, Daniel B. Gurick, Alanna T. Johnson, Kenneth C. Klotz, Murdo A. Montgomery, Mario R. Palladinetti and Barbara K. Sima (Ruling numbers 14-03-12-05-A; 14-03-12-05-B ; 14-03-12-05-C ; 14-03-12-05-D ; 14-03-12-05-E ; 14-03-12-05-F, 14-03-12-05-G, 14-03-12-05-H, 14-03-12-05-I, 14-03-12-05-J, 14-03-12-05-K ; transcript pages 13-15).
6. By a vote of 3-0, approved the termination of the casino key employee licenses held by Tammi L. Anderson, Stanford G. Le, Mohammad A. Mamun, Daniel S. Revallo, Angel L. Reyes, Matthew E. Sievers, Dominique P. Wilkins and Brenda Y. Williams (Ruling numbers 14-03-12-06-A; 14-03-12-06-B ; 14-03-12-06-C ; 14-03-12-06-D; transcript pages 15-16).
7. Adjourned the petition of Golden Nugget Atlantic City, LLC. (*d/b/a* Golden Nugget Hotel Casino), for the issuance of a temporary casino key employee license to Thomas Winter, pursuant to N.J.S.A. 5:12-89(e) and to permit him, pursuant to N.J.A.C. 13:69C-2.7 (c), to assume the duties and exercise the powers of The Vice President of Online Gaming of Golden Nugget Atlantic City, LLC, pending plenary qualification (PRN 0291404) (transcript page 16).
8. Considered the resubmission application of Eva L. Santiago for a casino key employee license and issued the following ruling:

By a vote of 3-0, found Eva L. Santiago, disqualified; denied her resubmitted application for a casino key employee license; and revoked her casino employee license (Docket 13-0006-CR) (Ruling number 14-03-12-08; transcript pages 16-19).

9. By a vote of 3-0, granted the initial application of Jennifer R. Fortucci, for a casino key employee license (DKT 14-0001-CK) (Ruling number 14-03-12-09; transcript pages 19-21).
  
10. Commissioner Cooper read into the record a Resolution of the Casino Control Commission acknowledging March as Problem Gambling Awareness Month, which was unanimously adopted (Ruling Number 14-03-12-10; transcript pages 21-24).
  
11. Considered the petition of Revel Entertainment Group, LLC and Revel AC, Inc. and issued the following rulings:  
  
By a vote 3-0, found good cause, and granted the requested relief until June 12, 2014; and
  - a) extended the period of temporary qualification to permit Scott C. Kreeger to continue to serve as President and Chief Operating Officer for Revel Entertainment Group and Revel AC, Inc., pursuant to N.J.A.C. 13:69C-2.7 (d) 2, and subject to the conditions in N.J.A.C. 13:69C-2.7; and
  - b) extended Mr. Kreeger's temporary casino key employee license, pursuant to N.J.S.A. 5:12-75(PRN 0701402) ) (Ruling number 14-03-12-11; transcript pages 24-28).

In accordance with Resolution No. 13-12-11-03, the next closed session of the Commission shall be held on Wednesday, April 9, 2014 at 9:30 a.m. in the Commission offices (transcript page 28).

There being no members of the public to address the Commission, the meeting adjourned at 10:50 a.m.
