WHEREAS, Mr. Sylvestre filed a Multi-Jurisdictional Personal History Disclosure Form and New Jersey Supplemental Form with the Commission and the Division of Gaming Enforcement (Division); and

WHEREAS, on August 7, 2012, the Division indicated no objection to the Commission granting the requested relief; and

WHEREAS, the Commission considered the matter at its public meeting on August 8, 2012;

WHEREAS, the Division of Gaming Enforcement indicated that a review of the employment titles of Vice President of Finance for Bally's Atlantic City,







JENKIN PURSUANT TO N.J.A.C. 13:69C-2.7(d)(2) (DGE PRN 2121201)

WHEREAS, casino licensees Harrah's Atlantic City Operating Company, LLC (Harrah's), Showboat Atlantic City Operating Company, LLC (Showboat), Bally's Park Place, Inc., (Bally's) Boardwalk Regency Corporation (BRC) and their holding companies Caesars Entertainment Corporation (CEC) and Caesars Entertainment Operating Company, Inc. (CEOC) filed DGE PRN 3401102 on December 6, 2011, seeking permission for Thomas M. Jenkin to assume the duties and exercise the powers of President of Operations of CEC and CEOC prior to his plenary qualification; and

WHEREAS, on December 14, 2011, the Casino Control Commission (Commission) with the recommendation of the Division of Gaming Enforcement (Division) granted the requested ruling for a nine-month period in accordance with the conditions contained in N.J.A.C. 13:69C-2.7 (Resolution No. 11-12-14-6); and

WHEREAS, Thomas M. Jenkin filed a Personal History Disclosure Form-MJ and NJ Supplemental on December 19, 2011; and

WHEREAS, the Division of Gaming Enforcement has indicated that it will not be able to complete its investigation and report to the Commission regarding Mr. Jenkin's

plenary qualification prior to the expiration of the nine-month period of temporary qualification on September 13, 2012; and


WHEREAS, CEC, CEOC, Harrah's, Showboat, Bally's and BRC (Petitioners) filed DGE PRN 2121201 on July 30, 2012, seeking to establish good cause pursuant to *N.J.A.C. 13:69C-2.7(d)2* for a ruling extending the nine-month period for a period of 90 days from September 13, 2012; and

WHEREAS, the Division does not object to the Commission granting the requested relief; and

WHEREAS, the Commission considered the matter at its public meeting of August 8, 2012;

NOW, THEREFORE, BE IT RESOLVED by the Commission that (a) good cause has been established pursuant to *N.J.A.C. 13:69C-2.7(d)2* to extend the period of temporary qualification of Thomas M. Jenkin; and (b) Thomas M. Jenkin is hereby authorized to continue to perform the duties and exercise the powers of President of Operations for CEC and CEOC pending plenary qualification and for a period not to exceed 90 days from September 13, 2012, subject to the conditions in *N.J.A.C. 13:69C-2.7*, as applicable.


