
WHEREAS, Governor Chris Christie has designated March 2014 as Problem Gambling Awareness Month in the State of New Jersey.

WHEREAS, casino licensee Revel Entertainment Group, LLC (Revel) filed PRN 1761301 on June 25, 2013 seeking a temporary casino key employee license pursuant to N.J.S.A. 5:12-89e for Scott C. Kreeger in the position of Executive Director Casino Operations; and

WHEREAS, on July 2, 2013, the Casino Control Commission (Commission), with the consent of the Division of Gaming Enforcement (Division) granted a temporary casino key employee license to Mr. Kreeger, which is set to expire on April 2, 2014; and

WHEREAS, on July 2, 2013, as amended on July 5, 2013, Revel filed PRN 1841302 seeking Commission approval to have Mr. Kreeger, prior to his plenary qualification, assume the duties and exercise the powers of Interim Chief Operating Officer for Revel and its holding company Revel AC, Inc. (Revel AC); and

WHEREAS, on July 10, 2013, the Commission, with the recommendation of the Division granted the temporary qualification for a nine-month period in accordance with the conditions contained in N.J.A.C. 13:69-2.7(c) and (d), which temporary qualification is set to expire on April 10, 2014 (Resolution No. 13-07-10-14); and

WHEREAS, Mr. Kreeger filed a Multi-Jurisdictional Personal History Disclosure Form and New Jersey Supplement Form on June 24, 2013; and

WHEREAS, the Division has indicated that it will not be able to complete its investigation and report to the Commission regarding Mr. Kreeger's plenary qualification and plenary casino key employee license prior to the expiration of temporary qualification on April 10, 2014 and the temporary casino key employee license on April 2, 2014; and

WHEREAS, Petitioners', Revel and Revel AC, filed PRN 0701402 on March 11, 2014, seeking an extension to the temporary qualification pursuant to *N.J.A.C. 13:69C-2.7(d)2* and an extension to the temporary casino key employee license pursuant to *N.J.S.A. 5:12-89(e)* and *N.J.S.A. 5:12-75* until June 12, 2014; and

WHEREAS, the Division does not object to the Commission granting the requested relief; and

WHEREAS, the Commission considered the matter at its public meeting of March 12, 2014;

NOW, THEREFORE, BE IT RESOLVED by the Commission that (a) good cause has been established pursuant to *N.J.A.C. 13:69C-2.7(d)2* to extend the period of temporary qualification of Scott Kreeger; (b) Scott Kreeger is hereby authorized to continue to perform the duties and exercise the powers of President and Chief Operating Officer for Revel and Revel AC pending plenary qualification until June 12, 2014, subject to the conditions in *N.J.A.C. 13:69C-2.7*, as applicable; and (c) that pursuant to *N.J.S.A. 5:12-89(e)* and *N.J.S.A. 5:12-75*, the temporary casino key employee license of Scott Kreeger is extended until June 12, 2014.
