WHEREAS, Caesars Interactive Entertainment, Inc. (CIE) is a qualified holding company of casino licensee Caesars Interactive Entertainment New Jersey, LLC; and

WHEREAS, Rock Gaming Interactive, LLC (Rock Gaming) is a Delaware limited liability company owned 70.3786% by DGCIE, LLC (DGCIE), a Michigan limited liability company; and

WHEREAS, Rock Gaming holds 6,536.7903 shares, or approximately 4.9%, of CIE common stock, and holds two convertible promissory notes convertible to an additional 8,913.71 shares, or approximately 6%, of CIE common stock, and Rock Gaming and DGCIE have been designated by the Division of Gaming Enforcement (Division) as entity qualifiers pursuant to *N.J.S.A.* 5:12-85.1; and
