**WHEREAS**, on July 11, 2018, the New Jersey Casino Control Commission (Commission), with the recommendation of the Division of Gaming Enforcement (Division), granted Elizabeth Louise Price temporary casino key employee license #10043-11, with a waiver of the residency requirement pursuant to N.J.S.A. 5:121-89(b)(4) and -89(e), and found Ms. Price temporarily qualified to serve as the Chief Compliance Officer for casino licensee HR Atlantic City, LLC (HRAC) and its holding company Seminole HR Holdings, LLC (Holdings) (Resolution No. 18-07-11-11); and

**WHEREAS**, the Division filed a letter report dated March 13, 2019, recommending that the Commission find Ms. Price plenary qualified to serve

as the Chief Compliance Officer for HRAC and Seminole and grant her initial casino key employee license #10043-11, but for residency as permitted by N.J.S.A. 5:12-89(b)(4); and



**WHEREAS**, the Commission considered the matter in its entirety at its public meeting on April 10, 2019;


