ORDER

The Division of Gaming Enforcement (“**Division**”), having reported on the resubmission application of Francesco Martire (“**Applicant**”) for casino key employee license #7313-11; and the Division and Applicant having entered into a Stipulation of Settlement (“**Stipulation**”) which was submitted to the New Jersey Casino Control Commission (“**Commission**”); and the Commission being unaware of Applicant having been involved in any other matters inconsistent with licensure; and the Commission having considered this matter in its entirety at its public meeting on July 3, 2024;

IT IS on this **3rd** day of **July 2024**, **ORDERED** that the Stipulation, which is incorporated herein by reference, is **APPROVED** and the resubmission application for casino key employee license #7313-11 is **GRANTED**; and

IT IS FURTHER ORDERED that Applicant has established his qualifications for licensure as a casino key employee as required by N.J.S.A. 5:12-89(b)(1) and -89(b)(2) of the Casino Control Act (“**Act**”) based on the credible evidence submitted including Applicant’s voluntary agreement to remain compliant with his Internal Revenue Service (“**IRS**”) Nelnet payment plan and provide the Division with proof of such payments on an annual basis beginning November 15, 2024; and


