



**WHEREAS**, casino licensee Boardwalk 1000, LLC ("Boardwalk") d/b/a Hard Rock Hotel & Casino Atlantic City ("HR Casino"), and casino licensee and manager of HR Casino, HR Atlantic City, LLC ("HR Atlantic City") having filed a Joint Petition (PRN 3622403) dated December 27, 2024, and amended by Letter Amendment dated December 31, 2024, seek the issuance by the New Jersey Casino Control Commission ("Commission") of an initial casino key employee license to Jeffrey E. Hook, with a waiver of the residency requirement, and a multi-casino endorsement pursuant to N.J.S.A. 5:12-89b(4) and -89e and N.J.A.C. 19:41A-5.3, and for the qualification of Jeffrey E. **WHEREAS**, on or about August 30, 2018, Jeffrey E. Hook filed a Multi-Jurisdictional Personal History Disclosure Form (MJ PHD) and New Jersey Supplemental Form in connection with his appointment as Vice President of Marketing for HR Casino and was issued a temporary casino key employee license and found temporarily qualified by the Commission in connection therewith (Commission Resolution No. 18-10-10-12), which temporary casino key employee license and temporary qualification expired as the position was permanently filled by another appointee; and

**WHEREAS**, Seminole Hard Rock Support Services, LLC (SHRSS) is the holder of a casino service industry enterprise license issued by the Division of Gaming Enforcement ("Division") pursuant to *N.J.S.A. 5:12-92a(1)*, and Jeffrey E. Hook was found plenarily qualified by the Division on June 4, 2020 in connection with his position as Executive Vice President and Chief Marketing Officer of SHRSS, and has continuously remained qualified as a natural person qualifier of SHRSS; and





RESOLUTION OF THE NEW JERSEY CASINO CONTROL COMMISSION CONCERNING THE PETITION OF MARINA DISTRICT DEVELOPMENT COMPANY, LLC FOR THE TEMPORARY QUALIFICATION OF TRAVIS T. TRUONG TO SERVE AS ITS VICE PRESIDENT OF ASIAN MARKETING PURSUANT TO *N.J.A.C. 13:69C-2.6* AND FOR THE ISSUANCE OF A TEMPORARY CASINO KEY EMPLOYEE LICENSE PURSUANT TO *N.J.S.A. 5:12-89b(4)* and *-89e* and *N.J.A.C. 19:41A-5.3* (PRN 3622402)

**WHEREAS**, casino licensee, Marina District Development Company, LLC (“MDDC”) d/b/a Borgata Hotel Casino & Spa, having filed a Petition (PRN 3622402) dated December 27, 2024 seeking approval of the New Jersey Casino Control Commission (“Commission”) to have Travis T. Truong, prior to plenary qualification, assume the duties and exercise the powers of Vice President of Asian Marketing for MDDC for a nine-month period in accordance with the conditions contained in *N.J.S.A. 5:12-85.1* and *N.J.A.C. 13:69C-2.6*; and

**WHEREAS**, Petitioner also seeks the issuance of a temporary casino key employee license to Travis T. Truong pursuant to *N.J.S.A. 5:12-89b(4)* and *-89e* and *N.J.A.C. 19:41A-5.3*; and

**WHEREAS**, on or about December 24, 2024, Travis T. Truong filed an initial application for a casino key employee license with the Commission as required by *N.J.S.A. 5:12-89* and *N.J.A.C. 19:41A-5.3(d)*, including a Multi-Jurisdictional Personal History Disclosure Form (PHD-MJ) and New Jersey

Supplemental Form, which was reviewed by the Division of Gaming Enforcement ("Division"); and

**WHEREAS**, the Division filed an email response dated January 6, 2025 in which it indicated that it did not object to the issuance of a temporary casino key employee license and the granting of temporary qualification to permit Travis T. Truong to assume the duties and exercise the powers of Vice President of Asian Marketing for MDDC pending casino key employee licensure and plenary qualification; and

**WHEREAS**, the Division consents to the Commission consideration of the requested relief prior to the expiration of the period specified in *N.J.S.A. 5:12-89e(2)*; and

**WHEREAS**, the Commission considered the entire record of the proceedings at its public meeting of January 8, 2025.

**NOW, THEREFORE, BE IT RESOLVED** by the Commission that Travis T. Truong be issued a temporary casino key employee license pursuant to *N.J.S.A. 5:12-89b(4)* and *-89e* and *N.J.A.C. 19:41A-5.3* pending plenary licensure; and

**IT IS FURTHER RESOLVED** by the Commission that Travis T. Truong is temporarily qualified and is hereby authorized to assume the duties and exercise the powers of Vice President of Asian Marketing for MDDC pending plenary






