





RESOLUTION OF THE NEW JERSEY CASINO CONTROL COMMISSION CONCERNING THE JOINT PETITION OF CAESARS ENTERTAINMENT, INC., WILLIAM HILL U.S. HOLDCO, INC. AND CAESARS INTERACTIVE ENTERTAINMENT NEW JERSEY, LLC REQUESTING ISSUANCE OF A TEMPORARY CASINO KEY EMPLOYEE LICENSE TO RINJU MATHEW PURSUANT TO *N.J.S.A. 5:12-89(e)* AND FOR PERMISSION FOR HIM TO ASSUME THE DUTIES AND EXERCISE THE POWERS OF DIRECTOR OF I-GAMING COMPLIANCE FOR CAESARS INTERACTIVE ENTERTAINMENT NEW JERSEY, LLC AND FOR A WAIVER OF THE NEW JERSEY RESIDENCY REQUIREMENT PURSUANT TO *N.J.S.A. 5:12-89(b)(4)* (PRN 2232505)

WHEREAS, Internet Gaming Affiliate casino licensee, Caesars Interactive Entertainment New Jersey, LLC ("CIENJ") and its qualified holding companies, Caesars Entertainment, Inc. ("CEI") and William Hill U.S. Holdco, Inc. ("WH US") having filed a Joint Petition (PRN 2232505) dated August 11, 2025, seeking approval of the New Jersey Casino Control Commission ("Commission") to have Rinju Mathew, prior to plenary qualification, assume the duties and exercise the powers of Director of I-Gaming Compliance for CIENJ for a nine-month period in accordance with the conditions contained in *N.J.S.A. 5:12-85.1* and *N.J.A.C. 13:69C-2.6* and 2.7; and

WHEREAS, Petitioners also seek the issuance of a temporary casino key employee license to Rinju Mathew, with a waiver of the residency requirement, pursuant to *N.J.S.A. 5:12-89b(4)* and -89e and *N.J.A.C. 19:41A-5.3*; and

WHEREAS, on or about August 3, 2025, Rinju Mathew filed an initial application for a casino key employee license with the Commission as required

by *N.J.S.A. 5:12-89* and *N.J.A.C. 19:41A-5.3(d)*, including a Multi-Jurisdictional Personal History Disclosure Form and New Jersey Supplement; and

WHEREAS, by response dated August 20, 2025, the Division of Gaming Enforcement ("Division") interposed no objection to the relief requested in the Joint Petition nor to the Commission issuing a temporary casino key employee license to Rinju Mathew, with a waiver of the residency requirement, and permitting him to assume the duties and exercise the powers of Director of I-Gaming Compliance for CIENJ prior to plenary qualification; and

WHEREAS, the Commission considered the entire record of the proceedings at its public meeting of September 10, 2025.

NOW, THEREFORE, BE IT RESOLVED by the Commission that Rinju Mathew be issued a temporary casino key employee license with a waiver of the residency requirement pursuant to *N.J.S.A. 5:12-89b(4)* and -89e and *N.J.A.C. 19:41A-5.3* pending plenary licensure; and


