It is anticipated that over 5,000 children (families) will be provided case management yearly in the nine most heavily Sandy impacted counties.

<b>Selection Standards:</b>								
Existing Special Child Case Management grants will be amended for agencies in impacted counties with potential for expansion.								
<b>Eligibility Standards:</b>								
Targeted assistance will be directed to the 9 most heavily impacted counties in New Jersey (Atlantic, Bergen, Cape May, Essex, Hudson, Middlesex, Monmouth, Ocean, and Union).
