The goal of this program is to inform the public of these hazards, train staff to recognize the hazards, and test children for potential lead poisoning.

<b>Selection Standards:</b>								
Services will be provided to essential partners, identified via an RFP to Regional Childhood Lead Poisoning Prevention (CLPP) Coalitions, local health departments, and county health departments within New Jersey's nine most Sandy-impacted counties (Atlantic, Bergen, Cape May, Essex, Hudson, Middlesex, Monmouth, Ocean, and Union).								
<b>Eligibility Standards:</b>								
Targeted assistance will be directed to the 9 most heavily impacted counties in New Jersey (Atlantic, Bergen, Cape May, Essex, Hudson, Middlesex, Monmouth, Ocean, and Union).
