FIRST EXTENSION AND MODIFICATION TO THE MEMORANDUM OF AGREEMENT BETWEEN

NEW JERSEY DEPARTMENT OF HEALTH DIVISION OF EPIDEMIOLOGY, ENVIRONMENTAL, AND OCCUPATIONAL HEALTH

AND CDC FOUNDATION FOR

COVID-19 EPIDEMIOLOGIC AND CONTACT TRACING SUPPORT

This First Modification is hereby incorporated as an addendum to the Memorandum of Agreement (MOA) entitled, "COVID-19 EPIDEMIOLOGIC AND CONTACT TRACING SUPPORT" effective April 1, 2021 through November 30, 2022, between the New Jersey Department of Health (NJDOH) and CDC Foundation each individually referred to as a "Party" and collectively as the "Parties," which is entered into the day and year last written below, and In this First Extension and Modification, the parties agree to extend the agreement and modify the MOA as set out below.

NOW THEREFORE, in consideration of the mutual promises, covenants and agreements hereinafter contained, the Parties do hereby covenant and agree as follows:

- 1. The MOA is modified as follows:
 - a. Replace the first sentence of Section I(B) with the following:
 "This Agreement is being entered as a "waivered contract" pursuant to N.J.S.A.
 52:34-8, 10(b), and 10(c) and pursuant to New Jersey Treasury Circular 23-03-OMB."
 - b. Amend the first paragraph set forth at Section III(A)1 to insert the following language below the third line:
 - "• Additional \$10,658,181.43 for the period from March 1, 2022 to July 31, 2024."
 - c. Section IV(A)5 is hereby deleted and replaced with the following language:

"The CDC Foundation will provide Funding Agency with 14 computer monitors and docking stations. The CDC Foundation will also provide Funding Agency with 18 additional cell phones for the Data Modernization field employees. NJDOH may retain all supplies purchased with their grant funds."

d. The table set forth at Section IV(A)11 is deleted and replaced with the below tables:

- e. The following new paragraph is inserted as paragraph IV(A)(14): "The CDC Foundation shall complete the Certification of Non-Involvement in Prohibited Activities in Russia or Belarus Pursuant to P.L. 2022, c. 3, which is attached hereto as Attachment C and incorporated herein by reference."
- f. In the first paragraph set forth at Section V(A) the text "November 30, 2022" is deleted and replaced with "July 31, 2024."
- g. In the first paragraph set forth at Attachment A Section I(A), the following language is added "All payments shall be made within 60 days of receipt of invoice."
- h. In the first paragraph set forth at Attachment A Section II(A), the following language is added "CDC Foundation shall provide individual invoices for each category of services provided, noting on the invoice the specific category for which the services were rendered in accordance with the revised budget included in Attachment B."
- i. Attachment B is amended to include the attached revised budget.
- j. The document entitled "Certification of Non-Involvement in Prohibited Activities in Russia or Belarus Pursuant to P.L. 2022, c.3" is inserted into the MOA as new Attachment C.
- k. CDC Foundation shall comply with secure protection and handling of confidential information and data in accordance with applicable law and Attachment D which is hereby incorporated by reference.
- 2. A portion of the project period covered by this MOA Modification is retroactive. Neither party will incur a penalty as a result of that retroactive period

¹ Engaged in prohibited activities in Russia or Belarus" means (1) companies in which the Government of Russia or Belarus has any direct equity share; (2) having any business operations commencing after the effective date of this act that involve contracts with or the provision of goods or services to the Government of Russia or Belarus; (3) being headquartered in Russia or having its principal place of business in Russia or Belarus, or (4) supporting, assisting or facilitating the Government of Russia or Belarus in their campaigns to invade the sovereign country of Ukraine, either through in-kind support or for profit.

Attachment D Secure Protection and Handling of DOH Data by CDC Foundation

- 1. **Agreement Purpose:** This document is hereby incorporated into and provides for additional provisions and conditions between the New Jersey Department of Health (DOH) and the CDC Foundation, to support DOH epidemiologic and contact tracing program, COVID-19 Epidemiologic and Contact Tracing Support (MOA).
- 2. **Data Classification and Confidentiality:** DOH Data shall mean any Personally Identifiable Information (PII) or any other confidential data or information to which CDC Foundation receives or otherwise has access pursuant to the provision of services under the MOA and shall be classified as highly confidential and secured as such, as defined by the New Jersey Statewide Information Security Manual, https://www.nj.gov/it/docs/ps/NJ_Statewide_Information_Security_Manual.pdf.
- 3. Compliance with the Law for the Use and Disclosure of Confidential Information: The CDC Foundation agrees to preserve the confidentiality, integrity and accessibility of DOH Data. CDC Foundation shall not re-use DOH Data. CDC Foundation agrees that any and all DOH Data exchanged shall be used expressly and solely for the purpose of the MOA to support DOH compliance with State law in controlling and suppressing communicable infectious disease. CDC Foundation shall not share, disclose, distribute, repurpose or share across other applications, environments, or business units of CDC Foundation DOH Data. CDC Foundation further agrees that DOH Data is confidential, subject to requirements of State Communicable Disease law and rules (N.J.S.A. 26:4-1, et seq. and N.J.A.C. 8:57-1.1, et seq.) and no DOH Data of any kind shall be shared, disclosed, distributed, transmitted, exchanged or otherwise passed to other third parties except on a case-bycase basis as specifically authorized in writing through an addendum to this Agreement.
- 4. End of MOA and Agreement Data Handling. CDC Foundation agrees that upon termination of the above referenced MOA, CDC Foundation shall be off-boarded and any access to DOH Data and the State's infrastructure shall be terminated. This Agreement does not grant any implied intellectual property licenses to DOH Data. CDC Foundation shall, upon termination of the above referenced MOA, securely and permanently destroy all DOH Data in CDC Foundation's possession accordance with NIST Special Publication 800-88, rev. 1, Guidelines for Media Sanitization.

5. Privacy & Security Breach Notification.

CDC Foundation agrees to comply with all applicable laws that require the notification of individuals in the event of unauthorized release of personally identifiable information or other event requiring notification caused by CDC Foundation. In the event of a breach of any of CDC Foundation's security obligations, or other event requiring notification under applicable law, CDC Foundation agrees to:

- a. Notify DOH Program Manager by telephone and e-mail of such an event immediately upon discovery, and
- b. Assume responsibility for informing all such individuals in accordance with applicable law, and
- c. Indemnify, hold harmless and defend DOH and its employees from and against any claims, damages, or other harm related to such notification event.
- 6. **Right to Audit.** DOH or an appointed audit firm (Auditors) has the right to audit CDC Foundation and any affiliates that provide a service for the processing, transport or storage of DOH's data. DOH will announce its intent to audit CDC Foundation by providing at a minimum two weeks (10 business days) notice to CDC Foundation. This notice will go to the signatory of this Agreement. A scope document along with a request for deliverables will be provided at the time of notification of an audit. CDC Foundation will make necessary employees or CDC Foundations available for interviews in person or on the phone during the time frame of the audit. Audits will be at DOH's sole expense, except where the audit reveals material noncompliance with MOA specifications, in which case the cost will be borne by CDC Foundation.
