NJ TRANSIT acknowledges receipt of TFCRC's letter no. TFC-NJT-OM6837 dated June 30, 2020, which submitted TFCRC's proposal in the amount of \$662,762.15 for the cleaning and sanitizing of the stations, facilities and light rail vehicles for the HBLRT System.

In accordance with Book III, Volume 1, Section 11.1.1.2, TFCRC is hereby directed to proceed with the work for O&M/NPC No. 106 – Stations, Facilities and Light Rail Vehicles COVID-19 Cleaning on a time and materials basis with an upset limit in the amount of \$656,218.39 for the period of March 15, 2020 to December 31 2020. This authorization is subject to early termination at NJ TRANSIT's sole discretion. All costs are to be supported by invoices from the service suppliers and vendors. All work shall be performed in accordance with the Contract, as amended, and the attached Rider.

The upset limit in the amount of \$656,218.39 reflects the deletion of Contractor Insurance costs in the amount of \$6,543.76, pending the review by NJ TRANSIT of the proposed markup rate of 0.9972% and negotiation of a current rate.
