B-1 HUMAN SERVICES AIDE, BILINGUAL IN ARABIC AND ENGLISH; AND HUMAN SERVICES AIDE, BILINGUAL IN URDU AND ENGLISH – CSC DOCKET NO. 2020-756

The Division of Agency Services requests the creation of the noncompetitive titles of Human Services Aide, Bilingual in in Arabic and English and Human Services Aide, Bilingual in Urdu and English.

ACTION: The Civil Service Commission directed that this request be granted.

B-2 D.M. – CSC DOCKET NO. 2018-3419

D.M., represented by Ricardo Gonzalez, Esq., appeals his rejection as a Police Officer candidate by the

City of Newark and its request to remove his name from the eligible list for Police Officer (S9999U) on the basis of psychological unfitness to perform effectively the duties of the position.

ACTION: The Civil Service Commission directed that this appeal be denied.

B-3 [J.P.](#) – CSC DOCKET NO. 2019-2973

J.P. appeals the removal of his name from the eligible list for Correctional Police Officer (S9988U), Department of Corrections on the basis of an unsatisfactory criminal record.

ACTION: The Civil Service Commission directed that this appeal be granted.

B-4 [HORTICULTURIST \(C0673W\), BURLINGTON COUNTY](#) – CSC DOCKET NO. 2020-466

The County of Burlington requests permission not to make an appointment from the February 14, 2019 certification for Horticulturist (C0673W), Burlington County.

ACTION: The Civil Service Commission granted the appointment waiver and assessed selection costs in the amount of \$2,048.

B-5 [BETTY CALLE](#) – CSC DOCKET NO. 2020-12

Betty Calle requests that the eligible list for Social Work Supervisor (PC2710T), Camden County Board of Social Services be revived and that she be appointed.

ACTION: The Civil Service Commission directed that this request be denied.

ACTION: The Civil Service Commission directed that this appeal be denied.

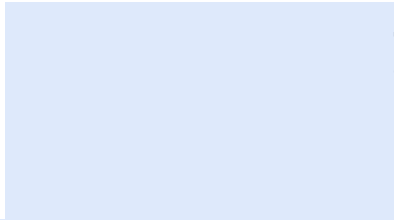
B-22 [SUNDERDAT SOOKRAM](#) – CSC DOCKET NO. 2020-149
