List Extension

The appointing authority for the Camden County requests that the eligible list for Juvenile Detention Officer (C0788P), be extended for one year beyond its original expiration date.

By way of background, the subject eligible list promulgated on April 18, 2013 and expires on April 17, 2015. Certification OL130608 resulted in eight appointments and Certification OL140041 resulted in two appointments. Certification OL141138 contains the names of 23 eligibles and disposition is due on March 3, 2015.

In the instant request, the appointing authority states that the eligible list is set to expire in April 2015 and that it does not believe that a new examination will be administered until January 2015, which would not be sufficient time for a roster to be in effect. Therefore, the appointing authority requests that the eligible list be extended to be part of the next cycle for testing. It is noted that the Division of Selection Services (Selection Services) indicates its agreement with the appointing authority's request. It states that based on Selection Services timeframes, the next announcement will not be issued until January 2015. Thereafter, the test shall be administered in May 2015 and the list will be issued in June or July of 2015. Therefore, the subject eligible list should be extended until a new list is available.

CONCLUSION

N.J.S.A. 11A:4-6 and *N.J.A.C.* 4A:4-3.3(b)1 provide that an eligible list may, for good cause, be extended, except that no list shall have a duration of more than four years.


In the present matter, the appointing authority states that based on the time frames as to when the next examination will be announced and when the examination will be administered there will not be sufficient time for a roster to be in effect. Moreover, Selection Services recommends extending the subject eligible list until the new one is available. Therefore, under these circumstances, good cause has been established to extend the eligible list for Juvenile Detention Officer (C0788P), Camden County for one year or until a new list is available.

ORDER

Therefore, it is ordered that this request be granted and the eligible list for Juvenile Detention Officer (C0788P), Camden County be extended until April 17, 2016 or until a new list is available.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.
