FINAL ADMINISTRATIVE ACTION OF THE CIVIL SERVICE COMMISSION

Administrative Appeal

ISSUED: 10 1 9 2015 (BS)

The Office of the Public Defender requests that Abigal Agosto's out-of-title work experience be accepted as qualifying experience for the title Supervisor Fiscal Accounts, Office of the Public Defender.

:

By way of background, Supervisor Fiscal Accounts requires three years of supervisory experience in the operation and maintenance of a complex system of accounts, including one year of responsibility for maintaining fiscal controls. The Division of Agency Services reviewed the qualifications of Ms. Agosto and concluded that although she possessed 16 years and nine months of supervisory experience in the operation and maintenance of a complex system of accounts, including one year of responsibility for maintaining fiscal controls, such responsibilities while serving in the titles Senior Technician, Management Information Systems and Head Clerk would constitute out-of-title work responsibilities which generally cannot be accepted as qualifying experience in promotional situations. See N.J.A.C. 4A:4-2.6(c).

The appointing authority requests that the Civil Service Commission accept Ms. Agosto's 16 years and nine months of out-of-title experience while serving in the titles Senior Technician, Management Information Systems and Head Clerk as qualifying experience for the Supervisor Fiscal Accounts title. The appointing authority certifies that Ms. Agosto has been working out-of-title as indicated in the Division of Agency Services' determination due to business necessity. Further, the appointing authority indicated that its Manager of Fiscal Resources supports this request.

#### **CONCLUSION**

*N.J.A.C.* 4A:4-2.6(c) provides that except when permitted for good cause, applicants for promotional examinations may not use experience gained as a result of out-of-title work to satisfy eligibility requirements.

In the present matter, the appointing authority requests that Ms. Agosto's out-of-title work responsibilities as a Senior Technician, Management Information Systems and Head Clerk be accepted as qualifying experience for the title Supervisor Fiscal Accounts. The Commission finds good cause to grant the request based on the Division of Agency Services' findings of out-of-title work in its determination and the endorsement of -Ms. Agosto's out-of-title work by the appointing authority.

### **ORDER**

Therefore, it is ordered that this request be granted and Abigal Agosto's out-of-title work as indicated above be accepted as qualifying experience for the title Supervisor Fiscal Accounts, Office of the Public Defender. Abigal Agosto is to provide a copy of this decision with the promotional application that she submits upon the issue of a promotional examination announcement. In addition, the Division of Agency Services shall also accept applicable and documented out-of-title work experience from other promotional examination applicants.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.
