List Revival

CSC Docket No. 2015-2507

ISSUED: APR - 6 2015 (LDH)

Montclair State University requests that the eligible list for Lieutenant, Campus Police (PS9978J), which expired on December 7, 2014, be revived and extended until December 7, 2015.

By way of background, the subject eligible list promulgated with five names on December 8, 2011 and expired on December 7, 2014. The list was never certified. As a result of an administrative error, the appointing authority failed to request a one year extension of the subject list during the life of the list. It requests a revival to make an appointment off the subject eligible list. It is noted that there is currently no new announcement or eligible list for the title and jurisdiction. Also, the Division of Agency Services recommends that the appointing authority's request be approved.

CONCLUSION

N.J.S.A. 11A:4-6 and *N.J.A.C.* 4A:4-3.4 provide that an eligible list may be revived in order to implement a court order or decision of the Civil Service Commission in the event of a successful appeal instituted during the life of a list, to correct an administrative error, or for other good cause. Additionally, *N.J.S.A.* 11A:4-6 and *N.J.A.C.* 4A:4-3.3(b)1 provide that an eligible list may, for good cause, be extended, except that no list shall have a duration of more than four years.

In the present matter, the appointing authority requests that the subject list be revived and extended so as to make an appointment off the subject list. In the


absence of such an extension, vacancies would have to be filled through provisional appointments, which are disfavored. Moreover, Agency Services supports the request. Thus, the appointing authority has demonstrated good cause to extend the Lieutenant, Campus Police (PS9978J), Montclair State University, eligible list until December 7, 2015.

ORDER

Therefore, it is ordered that this request be granted and the eligible list for Lieutenant, Campus Police (PS9978J), Montclair State University, be revived and extended until December 7, 2015.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.
