# FINAL ADMINISTRATIVE ACTION OF THE CIVIL SERVICE COMMISSION

In the Matter of Patrick Farrell, Sr. and Raul Robles, Senior Custodian (PM1491S), Jersey City School District

**Examination Appeals** 

CSC Docket Nos. 2015-2820 and 2015-2809

ISSUED: 301 1 6 2015 (SLK)

Patrick Farrell, Sr. and Raul Robles appeal the determinations of the Division of Agency Services (Agency Services) that they did not meet the experience requirements for the promotional examination for Senior Custodian (PM1491S), Jersey City School District. These appeals have been consolidated due to common issues presented.

The examination at issue was announced with specific requirements that had to be met as of the November 21, 2014 closing date (see attached). A total of 15 employees applied for the subject examination and two were deemed eligible. Certification PL150618 was issued containing the names of the two eligibles. The disposition of the certification is due September 1, 2015 and the eligible list expires on April 1, 2018.

Mr. Farrell indicated on his application that he was a Boiler Operator from June 2005 to the November 21, 2014 closing date. Personnel records indicate that he was a Boiler Operator from August 2011 to the November 21, 2014 closing date and a Custodial Worker from June 2006 to August 2011. Agency Services credited the appellant with having met the general experience requirement based on his experience as a Boiler Operator, but determined that he lacked one year of supervisory experience.

Mr. Robles indicated on his application that he was a Boiler Operator from April 2009 to November 2014. Personnel records indicate that he was provisionally appointed to the subject title on the November 21, 2014 closing date, a Boiler

Operator from April 2009 to the November 21, 2014 closing date, and a Custodial Worker from March 2002 to April 2009. Agency Services credited the appellant with having met the general experience requirement based on his experience as a Boiler Operator and one month of supervisory experience based on his provisional service in the subject title, but determined that he lacked 11 months of supervisory experience.

On appeal, Mr. Farrell amends his application and presents that he was a Senior Principal Custodian at the Glenn Cunningham School for six months, a Principal Custodian at Infinity High School, and that for the last five years he has been a licensed Boiler Operator at Infinity High School. As such, the appellant argues that he meets the requirements for the subject examination.

Mr. Robles asserts that in addition to meeting the general experience requirement, as a Boiler Operator for over five years, he supervised custodial staff.

# CONCLUSION

N.J.A.C. 4A:4-2.6(a) provides that applicants shall meet all requirements specified in the promotional announcement by the closing date.

N.J.A.C. 4A:4-2.6(d) provides that, except when permitted by the Civil Service Commission (Commission) for good cause, applicants for promotional examinations with open competitive requirements may not use experience gained as a result of out-of-title work to satisfy the requirements for admittance to the examination.

N.J.A.C. 4A:4-6.3(b) provides that the appellant has the burden of proof in examination appeals.

A review of the record indicates that Agency Services correctly determined that the appellants were not eligible for the subject examination as neither appellant demonstrated that they had the required supervisory experience. Any relevant supervisory experience that the appellants gained as Boiler Operators would be out-of-title-work. The appellants have not provided any documentation from the appointing authority that they were assigned out-of-title duties. Further, in reference to Mr. Farrell, under N.J.A.C. 4A:4-2.1(g), the Commission can accept clarifying information in eligibility appeals. However, N.J.A.C. 4A:4-2.1(f) provides that an application may only be amended prior to the announced closing date. For example, information submitted on appeal pertaining to duties in a given position that expands or enlarges information previously submitted is considered clarifying and is accepted. However, any documentation indicating work in a setting that was not previously listed on an application or resume cannot be considered after the closing date. Thus, the Commission can only consider information provided on appeal regarding the positions listed on the appellant's original application. See In

the Matter of Diana Begley (MSB, decided November 17, 2004). As such, the Commission cannot consider his experience as a Senior Principal Custodian and a Principal Custodian as these positions were not listed on his original application. It is also noted that even if the Commission were to consider these positions, personnel records do not indicate that Mr. Farrell served in these titles.

Therefore, there is no basis to disturb the decisions of Agency Services. Accordingly, the appellants have not met their burdens of proof in these matters.

# **ORDER**

Therefore, it is ordered that these appeals be denied.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.

Or to employees in the competitive division who have an aggregate of one year of continuous permanent service as of the closing date in any competitive title and meet the requirements listed below:

Experience: Two (2) years of experience in work involving the heating, inspection, cleaning, and maintenance of furniture, fixtures, offices, buildings, and in the reconditioning, care, and maintenance of grounds, one (1) year of which shall have been in a supervisory capacity.

Note: Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle rather than employee mobility, is necessary to perform the essential duties of the position. The responsibility for ensuring that employees possess the required motor vehicle license, commensurate with the class and type of vehicles they operate, rests with the Appointing Authority.
