# FINAL ADMINISTRATIVE ACTION OF THE CIVIL SERVICE COMMISSION

In the Matter of Hussein Ahmed and Michael Silvestri, Property Management Services Specialist 2 (PS9801U), Department of the Treasury

**Examination Appeals** 

CSC Docket Nos. 2015-3237 and : 2015-3188

Hussein Ahmed and Michael Silvestri appeal the determinations of the Division of Agency Services (Agency Services) that they were below the minimum requirements in experience for the promotional examination for Property Management Services Specialist 2 (PS9801U), Department of the Treasury. These appeals have been consolidated due to common issues presented.

The examination at issue was announced with specific requirements that had to be met as of the January 21, 2015 closing date (see attached). A total of three employees applied for the subject examination and one was deemed eligible. Certification PS141432 was issued containing the name of the one eligible and its disposition has not yet been recorded. The list expires on June 3, 2018.

On Mr. Ahmed's application, he indicated that he was provisionally serving in the subject title from December 2014 to the January 21, 2015 closing date, an Assistant Engineer, Civil for the Motor Vehicle Commission from October 2012 to December 2014, a Civil Engineer Trainee from April 2012 to October 2012, and a Civil Engineer for Edgewood Properties from May 2009 to May 2011. Personnel records indicate that he was provisionally serving in the subject title from December 2014 to the January 21, 2015 closing date, an Assistant Engineer, Civil from April 2013 to December 2014, and a Civil Engineer Trainee from April 2012 to April 2013. Mr. Ahmed also indicated that he possesses a Master's degree. Agency Services credited him for his education and two months for his provisional service in the subject title, but determined that he lacked one year and 10 months of experience.

On Mr. Silvestri's application, he indicated that he was provisionally serving in the subject title from May 2014 to the January 21, 2015 closing date, an Assistant Engineer, Civil for the Motor Vehicle Commission from January 2013 to May 2014, a Civil Engineer Trainee for the Motor Vehicle Commission from July 2012 to January 2013, a Security Officer for IPS Security from March 2009 to November 2011, and a Stage Crew for the Burlington County Institute of Technology from September 2005 to May 2008. Mr. Silvestri also indicated that he possesses a Bachelor's degree. Personnel records indicate that he was provisionally serving in the title under test from May 2014 to the January 21, 2015 closing date, an Assistant Engineer, Civil for the Motor Vehicle Commission from July 2013 to May 2014, and a Civil Engineer Trainee for the Motor Vehicle Commission from July 2012 to July 2013. Agency Services credited him for his education and nine months for his provisional service in the subject title, but determined that he lacked one year and three months of experience.

On appeal, Mr. Ahmed presents that he possesses a Bachelor's and Master's degree in Civil Engineering/Construction and Project Management, that he has over six years of experience as a Project Manager, including work in the private sector, three years with the Motor Vehicle Commission, and over six months with the appointing authority. Mr. Ahmed asserts that his supervisors have always highly rated his work, and he lists the duties that he has performed on projects throughout his career which he argues demonstrate that he meets the required experience.

Mr. Silvestri represents that the appointing authority provisionally appointed him to the subject title based on his two years of project management experience he gained while working for the Motor Vehicle Commission. Mr. Silvestri describes his current job duties and submits a resume which lists the job duties that he has performed throughout his career to demonstrate that he has the required experience.

It is noted that the Motor Vehicle Commission has confirmed that the appellants performed the required duties in construction management while employed by that agency.

## CONCLUSION

N.J.A.C. 4A:4-2.6(a) provides that applicants shall meet all requirements specified in the promotional announcement by the closing date. N.J.A.C. 4A:4-2.6(c) provides that applicants for promotional examinations with open competitive requirements may not use experience gained as a result of out-of-title work to satisfy the requirements for admittance to the examination or for credit in the examination process, unless good cause is shown for an exception. Further, N.J.A.C. 4A:1-1.2(c) states that the Civil Service Commission (Commission) may

relax a rule for good cause in order to effectuate the purposes of Title 11A, New Jersey Statutes.

Initially, Agency Services correctly determined that the appellants did not meet the required experience. As of the January 21, 2015 closing date, Mr. Ahmed only had two months of applicable experience and Mr. Silvestri only had nine months of experience as any other applicable experience they gained as Assistant Engineers, Civil would be out-of-title work. However, the Motor Vehicle Commission has confirmed that Mr. Ahmed performed the required out-of-title duties as an Assistant Engineer, Civil for one year and eight months from April 2013 to December 2014 and Mr. Silvestri performed the required out-of-title duties as an Assistant Engineer, Civil for 10 months from July 2013 to May 2014. Further, the record evidences that the eligible list is incomplete as there is only one name on the eligible list. Moreover, Mr. Ahmed and Mr. Silvestri continue to serve provisionally in the title under test. Therefore, under these circumstances, good cause exists to relax the provisions of N.J.A.C. 4A:4-2.6(a) and (c) and accept Mr. Ahmend's and Mr. Silvestri's out-of-title work and experience after the closing date, for eligibility purposes, and admit them to the subject examination.

# **ORDER**

Therefore, it is ordered that these appeals be granted, and Hussein Ahmed's and Michael Silvestri's applications be processed for prospective employment opportunities only.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.

Open to employees in the competitive division who are currently serving in a title to which the announcement is open and have an aggregate of one year of continuous permanent service as of the closing date in the following title(s):

### **Property Management Services Specialist 1**

Or to employees in the competitive division who have an aggregate of one year of continuous permanent service as of the closing date in any competitive title and meet the requirements listed below:

Education: Graduation from an accredited college or university with a Bachelor's degree. You must indicate either possession of a degree or total number of college credits completed to date on your application. (Foreign degrees/ transcripts must be evaluated by a recognized evaluation service.) Failure to do so will result in rejection from the examination process.

Applicants who do not possess the required education may substitute additional experience as indicated on a year for year basis with thirty (30) semester hour credits being equal to one (1) year of experience.

Experience: Two (2) years of experience in work involving real estate acquisition, financing, appraising, negotiation, property management, building operations, complex management, contract/grant administration, construction management services, or a related field.

License: Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle rather than employee mobility, is necessary to perform the essential duties of the position. The responsibility for ensuring that employees possess the required motor vehicle license, commensurate with the class and type of vehicles they operate, rests with the Appointing Authority.

- 1. NJAC 4A:4-2.6 states that all requirements listed, including assignment to the department and unit scope, must be met as of the closing date.
