FINAL ADMINISTRATIVE ACTION OF THE CIVIL SERVICE COMMISSION

In the Matter of Ayouba Kosiah, Senior Therapy Program Assistant (PS3882K), Hunterdon Developmental Center

Examination Appeal

CSC Docket No. 2019-505

ISSUED: OCTOBER 19, 2018 (SLK)

Ayouba Kosiah appeals the determination of the Division of Agency Services (Agency Services) that he did not meet the experience requirements for the promotional examination for Senior Therapy Program Assistant (PS3882K), Hunterdon Developmental Center.

The examination at issue was announced with specific requirements that had to be met as of the October 23, 2017 closing date. The requirements for the examination were three years of experience in work involving the care and custody of persons confined to a hospital facility or institution for those who have developmental disabilities, mental illness, and/or physical handicaps, assisting in the implementation of occupational, physical, recreational, and/or behavioral therapy programs to improve the well-being of clients through a variety of therapeutic and rehabilitative activities. A total of 50 employees applied for the subject examination. A test was administered on July 12, 2018 which resulted in a list of 24 eligibles. It is noted that the appellant sat for the subject test and received a passing score. However, after the test was administered, Agency Services determined that the appellant was admitted in error as his application was incomplete and it could not determine his eligibility. The list has not yet been certified.

On appeal, the appellant explains that, in 2012, he applied to a prior examination for a position in the subject title and he was determined eligible. He indicates that he attached his resume to his application for that examination and it

was his understanding that since he was determined eligible and his name had been certified to a list, his resume was still in this agency's system. Additionally, he submits a letter of support from a Head Cottage Training Supervisor. Further, the appellant attaches his current resume that describes how he has performed the required duties while provisionally serving in the subject title and as a Cottage Training Technician.¹

CONCLUSION

N.J.A.C. 4A:4-2.1(f) provides that an applicant may amend a previously submitted application only prior to the announced closing date. *N.J.A.C.* 4A:1-1.2(c) provides that a rule may be relaxed for good cause in a particular circumstance in order to effectuate the purposes of Title 11A, New Jersey Statutes.

Initially, Agency Services correctly determined that the appellant was not eligible for the subject examination as he did not list any experience on his application. On appeal, the appellant explains that he thought Agency Services already had his resume since he had submitted it for a prior examination for the subject title where he been determined eligible. Additionally, on appeal, he submits a current resume that describes how he has performed the required duties while provisionally serving in the subject title and as a Cottage Training Technician. The importance of submitting a properly completed application that includes all of the necessary information cannot be overstated, since a complete application provides the only reliable barometer by which Agency Services can make the initial determination whether to admit or reject an applicant. Agency Services has no other tool to rely on in order to make this important initial assessment in an expeditious, fair and efficient manner. Although N.J.A.C. 4A:4-2.1(f) proscribes the amendment of an application after the closing date set in the announcement, the Civil Service Commission (Commission) finds that for equitable reasons it shall accept the appellant's amendment to his application. Specifically, although mistaken, the appellant explained why he thought Agency Services already had his resume and he sat for and passed the test for the subject announcement. Further, the Commission notes that the dual purpose of the Civil Service system is to ensure efficient public service for State and local governments and to provide appointment and advancement opportunities to Civil Service employees based on their merit and abilities. These interests are best served when more, rather than fewer, individuals are presented with employment opportunities. See Communications Workers of America v. New Jersey Department of Personnel, 154 N.J. 121 (1998). In this regard, the Commission is satisfied that the appellant's experience performing the required duties while provisionally serving in the subject title and as a Cottage Training Technician starting in April 2007 warrants his admission to the subject

examination. Accordingly, good cause is established to relax the provisions of $N.J.A.C.\ 4A:4-2.1(f)$ and admit the appellant to the subject examination.

The Commission cautions the appellant that, in the future, he should ensure that any applications are fully and completely filled out as his failure to do so will be cause for rejection from the selection process. Finally, this determination is limited to the instant matter and does not provide precedent in any other matter.

ORDER

Therefore, it is ordered that the appeal be granted, and the appellant be added to the eligible list based on his examination score, for prospective employment opportunities only.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.
