**SECTION B – MISCELLANEOUS MATTERS****B-151 A.T. – CSC DOCKET NO. 2015-2407**

A.T. represented by Michael L. Prigoff, Esq., appeals his rejection as a Police Officer candidate by the Jackson Township Police Department and its request to remove his name from the eligible list for Police Officer (S9999M) on the basis of psychological unfitness to perform effectively the duties of the position.

**ACTION:****B-152 G.R. – CSC DOCKET NO. 2013-1333**

G.R., represented by Anthony M. Arbore, Esq., appeals the request by Morris County to remove her name from County Correction Officer (C9972M) eligible list for medical unfitness to perform effectively the duties of the position.

**ACTION:****B-153 SUPERVISING FAMILY SERVICE SPECIALIST 2 (PS1035K), SUPERVISING FAMILY SERVICE SPECIALIST 2 (BILINGUAL IN SPANISH AND ENGLISH) (PS1036K), SUPERVISING FAMILY SERVICE SPECIALIST 1 (PS1032K), SUPERVISING FAMILY SERVICE SPECIALIST 1 (PS1015K), AND FAMILY SERVICE SPECIALIST 1 (PS2267K) - CSC DOCKET NOS. 2017-313 *ET AL.***

Various applicants appeal the determinations of the Division of Agency Services which found that they were not eligible for the promotional examinations for Supervising Family Service Specialist 2 (PS1035K), Supervising Family Service Specialist 2 (Bilingual in Spanish and English) (PS1036K), Supervising Family Service Specialist 1 (PS1032K), Supervising Family Service Specialist 1 (PS1015K), and Family Service Specialist 1 (PS2267K) because they applied for the incorrect examination or were not employed in the announced unit scopes.

**ACTION:****B-154 STACY WHITE – CSC DOCKET NO. 2016-3279**

Stacy White appeals Hunterdon Developmental Center's request to remove her name from the special reemployment list for the title of Cottage Training Technician (Special), Hunterdon Developmental Center, due to her failure to complete preemployment processing.
