**B-26 JOSE RIVERA, III – CSC DOCKET NO. 2017-2085**

Jose Rivera, III, represented by Bette Grayson, Esq., appeals the removal of his name from the eligible list for Fire Fighter (M2545M), Kearny, on the basis of his failure to meet the residency requirement and an unsatisfactory background report.

Shilda Worthy, represented by Joseph Hannon, Esq., appeals the decision of the Division of Agency Services which found that her position with the Department of Health is properly classified as Program Specialist 1. The appellant seeks a Program Specialist 4 job classification.

**B-28 JOSE MORALES – CSC DOCKET NO. 2015-3209**

The appeal of Jose Morales, a Stationary Engineer with Hudson County, Division of Roads and Pubic Property, of his six-month suspension on charges, was heard by Administrative Law Judge Gail M. Cookson (ALJ), who rendered her initial decision on March 27, 2017. At its meeting on June 21, 2017, the Civil Service Commission (Commission) did not adopt the ALJ's recommendation to reverse the suspension. Rather, the Commission imposed a five working day suspension. The proposed decision is now submitted for the Commission's review.
