## **FIRE CHIEF**

## BATTALION FIRE CHIEF

The current announcements were released on July 1<sup>st</sup>, 2021. The written examination was administered on January 27, 2022. Candidate written exam review was held May 9-13, 16, and 17, 2022. The oral assessment exercises were administered May 19, 23, and 25, 2022.

The lists issued for most of the Battalion Fire Chief symbols on **February 8, 2023**.

These Battalion Fire Chief lists **were issued on Wednesday, February 15, 2023**: Camden PM3377C, Hoboken PM3385C, Newark PM3388C, Paterson PM3390C, Perth Amboy PM3392C, and Union Twp. PM3399C due to a delay in finalizing seniority for these jurisdictions. These lists **were promulgated on Thursday, February 16, 2023**.

Candidate review was held on March 1, 2, 6, 8, 9, 13, and 15, 2023. Information on reviews were included in the notices of eligibility/ineligibility.

The Civil Service Commission recently became aware of an issue with Battalion Fire Chief (BFC) candidate seniority scores and has conducted a thorough investigation. We have determined that incorrect seniority scores were used in the seniority score calculations for all candidates from the May 23, 2022 test date. The seniority scores for the other two BFC test dates are correct. However, since the scoring formulas for seniority incorporate seniority scores from the entire candidate population, these incorrect seniority scores affected final scores for all BFC candidates. This does not affect candidates' passing or failing status on the exam, but it does result in changes in candidates' final averages and some changes in candidate rank. The candidate lists for the following jurisdictions will not have any changes in candidate rank:

We understand the frustration and inconvenience this error has caused and are committed to ensuring that the testing and scoring process is fair, accurate, and transparent for all involved.

# ENTRY LEVEL FIREFIGHTER

*The Entry Level Firefighter Announcement opened on 7/1/22 and closed at 4:00 PM on 8/31/22.*

**On April 20, 2023, municipal Firefighter lists issued.** The lists themselves were **NOT** posted on the Civil Service Commission (CSC) website's usual look-up location ([NJ CSC - ELIGIBILITY LIST \(state.nj.us\)](https://www.nj.gov/csc/eligibility-list)). Instead, each candidate can use their applicant identification number to see their individual final average score and rank on each list for which they are eligible.

Passing candidates may appear on multiple municipal Firefighter lists dependent upon where they live (based on local residency ordinances and anticipated hiring needs). Candidates who are on multiple lists will have varying ranks (based on the candidate population in each jurisdiction) and in some cases different scores (if the candidate received additional volunteer points for being an active volunteer in a combination department for which they are eligible). In jurisdictions where a candidate did not volunteer, the candidate would **NOT** receive any additional points, so this candidate would have two different scores, one for the combination (volunteer) jurisdiction and another score for jurisdictions where they did not volunteer. Candidates for strictly paid fire departments (meaning that they are not a combination department) are **NOT** eligible to receive volunteer points.

If your rank is high enough on a list, **AND** firefighter vacancies exist in one of your eligible residency jurisdiction(s), your name may be certified by that jurisdiction's Appointing Authority (AA) for further consideration. Candidates certified from any 2023 eligible list are required to take and pass the Physical Performance Test (PPT) at the time of certification to be considered for appointment. Therefore, you should go to the CSC's website to review the Physical Fitness Manual and begin preparing for the possibility that

you will be scheduled to take the PPT. A link to the video overview of the PPT is available here:

If your name is certified by an AA, a Certification Notice (CN) will be sent to the mailing address you listed on your application. Therefore, you **MUST** notify the CSC directly if your mailing address or email address changes from the one you entered on your application. If you receive a CN in the mail, you will be given five business days from the notice date to respond in writing to the AA that you are interested, or not interested, in the job. If you do not respond within this timeframe, your name will be removed from the certification and you will no longer be considered for appointment.

After you respond to a CN that you are interested, you will receive an email from [PPTschedule@csc.nj.gov](mailto:PPTschedule@csc.nj.gov) that will have the Firefighter PPT Medical Clearance Form attached. You will be scheduled to take the PPT via the email address that you used to apply for the written examination. Once you are scheduled to take the PPT, you must report on your scheduled test date and time, with all required materials. Otherwise you will be removed from **ALL** Firefighter eligible lists. **Please check your spam folder and/or add the email address [PPTschedule@csc.nj.gov](mailto:PPTschedule@csc.nj.gov) to your safe-sender list.**

**The first PPT administration after the 2023 firefighter lists issue is now projected to begin in late June 2023.** Be sure that your list is certified as close to the promulgation date as possible and that your candidates are sent to [PPTschedule@csc.nj.gov](mailto:PPTschedule@csc.nj.gov) in a timely manner to ensure your candidates get tested in June of 2023.
