

EXAMINATION INFORMATION ALERT

Police Promotional Announcement and Testing Schedule 2025 (Includes County, Municipal, Palisades Interstate Park, Human Services, and State Park Police titles)

This alert is intended to notify Appointing Authorities (AAs) and police promotional candidates of the timeframes that will apply to the New Jersey Civil Service Commission's (NJCSC) 2025 announcement and testing schedule for in-line police promotional titles. Providing these dates in advance will assist AAs and potential promotional candidates with their respective planning needs. Candidates may also go the NJCSC's website (<u>www.nj.gov/csc</u>) when an announcement is issued, to obtain an <u>orientation guide</u> which will include the specific test date that corresponds to their promotional announcement.

As the above schedule reveals, NJCSC issues announcements annually for the titles of Police Sergeant, Lieutenant, and Captain, and semi-annually for the titles of Inspector, Deputy Chief, and Chief. Please note that the NJCSC will automatically initiate Sergeant, Lieutenant, and Captain announcements for most jurisdictions based on the expiration date of an existing list for a given municipality. However, if a promotional list is exhausted or is expected to be exhausted or rendered incomplete prior to its expiration date, an AA should initiate a new announcement and submit its request by the appropriate deadline indicated above. The tentative exam dates and formats in this alert may change due to many factors. Candidates should periodically check the Law Enforcement Status Report and orientation guides for updates (Law Enforcement Promotional Titles). Notifications to report to an exam will be emailed/mailed to eligible candidates a minimum of two weeks prior to the exam date. Candidates must notify NJCSC of any changes to contact information (postal/email/phone). Make-up exams for Public Safety titles are only granted as stated in N.J.A.C. 4A:4-2.9.
