## 2025 POLICE LIEUTENANT, PIP (PS1004V) EXAM INFORMATION SHEET

The purpose of this information sheet is to provide candidates who will be taking the 2025 Police Lieutenant, PIP exam with information that should be helpful in preparing for the exam. The *tentative* timeframe to administer the exam is <u>October 2025</u>. Candidate exam notices will be mailed two to three weeks prior to the test date and will confirm the test date, report time, and location.

The format of the exam will be multiple-choice. Topics in this exam may include, but are not limited to:

- Law Enforcement Practices
- Supervision of Law Enforcement Personnel
- Interpersonal/Community Relations Skills
- Report Writing and Effective Written Communication
- Interpreting and Applying Rules, Regulations, and/or Policies

While preparing for the exam, candidates may find it helpful to consult the following sources of information:

- N.J.S.A. 2C The N.J. Code of Criminal Justice
- New Jersey Attorney General Guidelines/Directives\*
- United States Constitution & Amendments
- Past & Current United States and New Jersey Court Decisions (Case Law)
- Palisades Interstate Parkway Commission Rules and Regulations (October 2018)

When preparing for the exam, it is the candidates' responsibility to ensure that they identify, access, and are familiar with the most up-to-date version of all Guidelines and Directives that are currently in effect.
