- Applications must be filed no later than the application filing date issued on the announcement. Make-up exams for professional engineering titles are only granted as stated in *N.J.A.C. 4A:4-2.9(b)*.
- Examinations will be held during the months indicated on this EIA barring unforeseen circumstances.
- Notifications to report to an exam will be emailed/mailed to eligible candidates a minimum of two weeks prior to the exam dates. Candidates must notify NJCSC of any [changes to contact information](#) (e.g., street address, email address, phone number).
