# ENTRY LEVEL FIREFIGHTER

**The 2024 Firefighter announcement opened at 12:00 am on July 1<sup>st</sup>, 2024, and will close at 4:00 pm on September 3<sup>rd</sup>, 2024.**

**The below information pertains to the 2022 Firefighter lists:**

If your name is certified by an AA, a Certification Notice (CN) will be sent to the mailing address you listed on your application. Therefore, you **MUST** notify the CSC directly if your mailing address or email address changes from the one you entered on your application. If you receive a CN in the mail, you will be given five business days from the notice date to respond in writing to the AA that you are interested, or not interested, in the job. If you do not respond within this timeframe, your name will be removed from the certification, and you will no longer be considered for appointment.

After you respond to a CN that you are interested, you will receive an email from [PPTschedule@csc.nj.gov](mailto:PPTschedule@csc.nj.gov) that will have the Firefighter PPT Medical Clearance Form attached. You will be scheduled to take the PPT via the email address that you used to apply for the written examination. Once you are scheduled to take the PPT, you must report on your scheduled test date and time, with all required materials. Otherwise, you will be removed from **ALL** Firefighter eligible lists. **Please check your spam folder and/or add the email address [PPTschedule@csc.nj.gov](mailto:PPTschedule@csc.nj.gov) to your safe-sender list.**

**The first PPT administration after the 2023 firefighter lists issued was held in late June 2023 and will continue monthly as needed.** Be sure that your list is certified as close to the promulgation date as possible and that your candidates are sent to [PPTschedule@csc.nj.gov](mailto:PPTschedule@csc.nj.gov) in a timely manner to ensure your candidates get tested in the quickest manner possible. If you are a new AA and need instructions on the at-time-of certification PPT please send us an email request to [PPTschedule@csc.nj.gov](mailto:PPTschedule@csc.nj.gov).

**The next Firefighter PPT administrations are tentatively scheduled to begin testing on Tuesday August 6<sup>th</sup>, Tuesday September 24<sup>th</sup>, and Tuesday October 22<sup>nd</sup>, 2024, at the Somerset Armory, 1060 Hamilton St. Somerset, NJ. \*July and August PPT were combined on August 6<sup>th</sup>.**
