**Summary** of Public Comments and Agency Responses:

A comment was received from Richard Soltis Jr.

1. COMMENT: The commenter states that the Department of Community Affairs (Department)

is changing the code for no particular reason and explains that the rulemaking makes it more

difficult for the public to navigate the code procedures. The commenter believes that the changes

to the code are superfluous and are not necessary, other than to align with changes in the adopted

code.

RESPONSE: The Department respectfully disagrees and the proposed changes to the code are

necessary for the proper understanding and adherence to applicable procedures and information.

The Department seeks to correct errors in numerical references within the table concerning Chapter 11 responsibilities. These changes are minor and are made to ensure the correct reference and exception are applied.
