By signing and submitting this Offer, the Bidder certifies and confirms that it hereby offers and agrees to furnish the goods, products, or services in compliance with all terms of this Master Blanket Purchase Order (Blanket P.O.) as set forth in this Offer and Acceptance page, the State of New Jersey Standard Terms and Conditions (SSTCs), the Request for Quote (RFQ), and the and the Vendor's Bidder's Quote. These documents are listed in order from highest to lowest in the event of a conflict.

1. The price of the goods or services being procured by the RFQ shall be no greater than the price offered to federal agencies.
2. The Vendor shall give the State federally mandated price reductions during the term of the Blanket P.O., if any are provided for in the Federal Supply Schedule contract or by law.
3. In the event of a termination, suspension, or expiration of the underlying Federal Supply Schedule, this State of New Jersey Blanket P.O. shall continue pursuant to the term set forth above unless otherwise terminated or suspended.
4. The Blanket P.O. shall have a list of the specific products or services being purchased and the prices for each. Only goods and services approved by the Director in writing shall be sold under the Blanket P.O.
5. The Bidder has read, understands, and agrees to all terms, conditions, and specifications set forth in the RFQ, the SSTCs and the provisions set forth in RFQ regarding MacBride Principles Certification, Subcontractor Certification, Non-Collusion, and New Jersey Business Ethics Guide Certification;
6. The Bidder must satisfy all the procurement requirements for State contracting, i.e., submitting the statutorily required forms and certifications. The required forms and certifications, are listed in the RFQ and are either included with the RFQ or are available on the Division of Purchase and Property web site.
7. The contractor shall secure and maintain in full force and effect for the term of the Blanket P.O. insurance as required by the RFQ. The contractor shall provide the State with current certificates of insurance for all coverages and renewals thereof.
8. The Contractor's failure to meet any terms and conditions of the Blanket P.O. as defined in the RFQ shall constitute a breach and may result in suspension or debarment from further State bidding.
9. A defaulting Contractor may also be liable, at the option of the State, for the difference between the Blanket P.O. price and the price submitted by an alternate vendor of the goods or services in addition to other remedies available.
