### **UNIFORM FIRE CODE**

Pursuant to the State Uniform Fire Safety Act (P.L. 1983, C 383), the New Jersey Department of Community Affairs, Division of Fire Safety, adopted a mandatory statewide uniform fire code.

This publication includes:

2. State statutes creating the Division, Fire Safety Commission, Fire Code and other fire related statutes.
3. New Jersey Administrative Codes that constitute regulations for the NJ Uniform Fire Code, Fire code Enforcement, High Level Alarms, Standards for Fire Service Training and Certification and other fire related regulations as well as Fire Safety Bulletins and Alerts.
