## NPU's "Park and Shop" Field Day

On November 22nd, 2024, NPU staff traveled to Gloucester City, NJ, to visit the newly renovated playground in Proprietors Park. Proprietors Park has been a staple in the Gloucester City community for years and recently went through a complete remodeling after the playground's dated equipment was no longer suitable for safe and accessible play. The renovations consisted of demolishing and replacing the old equipment, creating a new park sign, and adding picnic tables.

In addition to visiting Proprietors Park, the team also stopped by Haddon Ave. in Camden, NJ, to visit another NPP-revitalized site. Curate Noir, once a vacant building, is now a modern and inviting market that specializes in hosting events and showcasing local small businesses merchandise. The 2,000 sq. ft. shop featured several unique products for purchase, such as fresh honey, beautiful artwork, creative books, and more.

Both Proprietors Park and Curate Noir were funded by the Community Capital Needs grant through the Neighborhood Preservation Program.











## Exploring CCN Projects in Atlantic City and Somers Point

On September 9th, the NPU team visited Atlantic City and Somers Point, NJ, as part of the closeout process for the Community Capital Needs (CCN) Grant. The Community Capital Needs (CCN) Grants, administered through DCA's NRTC and NPP Programs, funded capital projects like infrastructure improvements, streetscapes, and commercial renovations to support community development in designated neighborhoods.

In Atlantic City's Ducktown neighborhood, the team toured Arctic Avenue, where CCN funds supported decorative LED streetlights, new sidewalks, and a 15-foot placemaking kiosk. These improvements are designed to enhance the area's appeal and attract businesses. The visit also included a stop at the Noyes Arts Garage of Stockton University, a 24-hour creative hub for artists, which also features the African American Heritage Museum of Southern NJ.

In Somers Point, the spotlight was on Bay Avenue, where brighter LED streetlights funded by the grant are enhancing safety and increasing foot traffic. The day ended with a productive meeting with city officials at City Hall regarding various NPU initiatives.
