



INVITATION TO BID

REQUEST FOR QUALIFIED INSULATION AND ENERGY EFFICIENCY CONTRACTORS

Saint Joseph's Carpenter Society (SJCS) intends to prequalify licensed and certified general contractors to provide material and labor for home energy efficiency measures, including but not limited to: insulation, air sealing, window installation and insulation, bathroom fan installation, ventilation measures, and other related work for the SJCS Weatherization Assistance Program (WAP) BIL and 2026-2027 LIHEAP and DOE programs as described in the 2026 NJ WAP State Plan. SJCS will receive qualification packages to qualify "Insulation and Energy Efficiency Contractors" (pursuant to [10 CRF Part 440](#)) at our corporate office located at 20 Church Street, Camden, NJ 08105. This RFQ can be received via email request to mmahon@sjcscamden.org or physically received at our offices any business day on or after August 11th, 2026.

Bidders are required to comply with the requirements of P.L 1975 C.127. Minority Business Enterprises (MBE) will be offered full opportunity to bid and will not be subject to discrimination on the basis of race, color, gender, or national origin in consideration of an award.

SJCS intends to select at minimum five (5) contractors whose proposals are the most advantageous to SJCS with price and other factors considered to be included in a prequalified pool of contractors to receive and have the ability to bid upon residential energy efficiency and insulation work scopes from SJCS. These pre-qualified contractors will have the ability to bid on all SJCS sponsored weatherization projects within Burlington County. If awarded a bid, the company/firm shall be required to comply with the requirements of NJ S.A. 10:5-31 et seq. and NJ A.C. 17:27 et sq. It is anticipated that SJCS will have an estimated thirty (30) weatherization jobs in 2026-2027.

Contractors will be required to pay local prevailing wages via the Davis-Bacon Act if a project includes a multi-family project with 5 units or more and contractors are encouraged to follow "Buy American" provisions as much as possible on each individual job.

SJCS reserves the right to reject any and all proposals when it is determined by SJCS to be in its best interest. SJCS further reserves the right to waive minor irregularities in proposals submitted in response to this RFQ.

Qualifications are due to SJCS on September 1st, 2026, at 3:00 pm. Emailed qualifications will not be accepted. Sealed physical qualifications delivered prior to September 2nd, 2026, will only be accepted. Questions to the RFQ are due by August 26th, 2026, at 12 pm. SJCS will not accept Qualifications or Questions after the times specified for submissions. Any Qualifications or questions received after these times will be deemed invalid. The RFQs will be opened September 2nd, 2026, at 10 am at 20 Church Street, Camden, NJ 08105.
