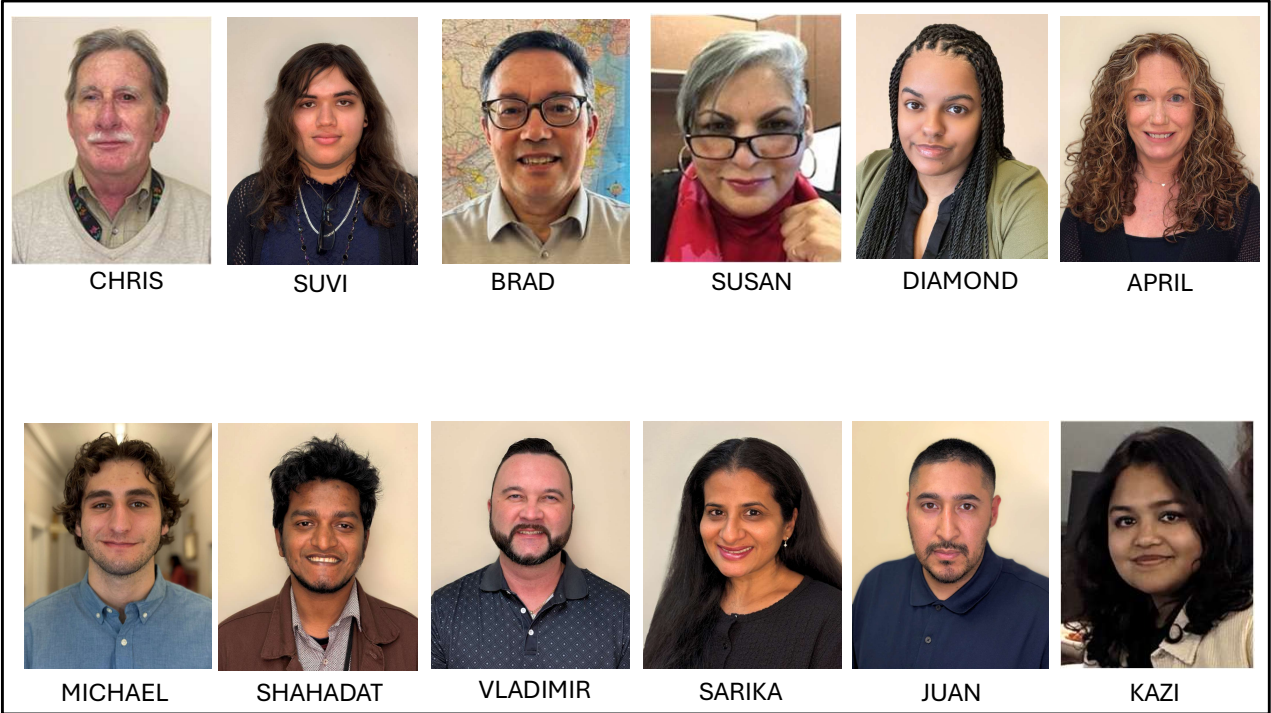

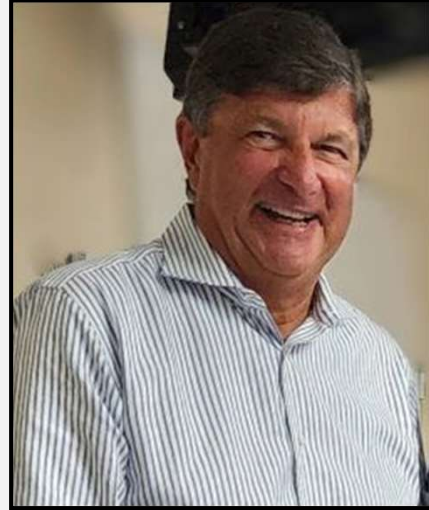

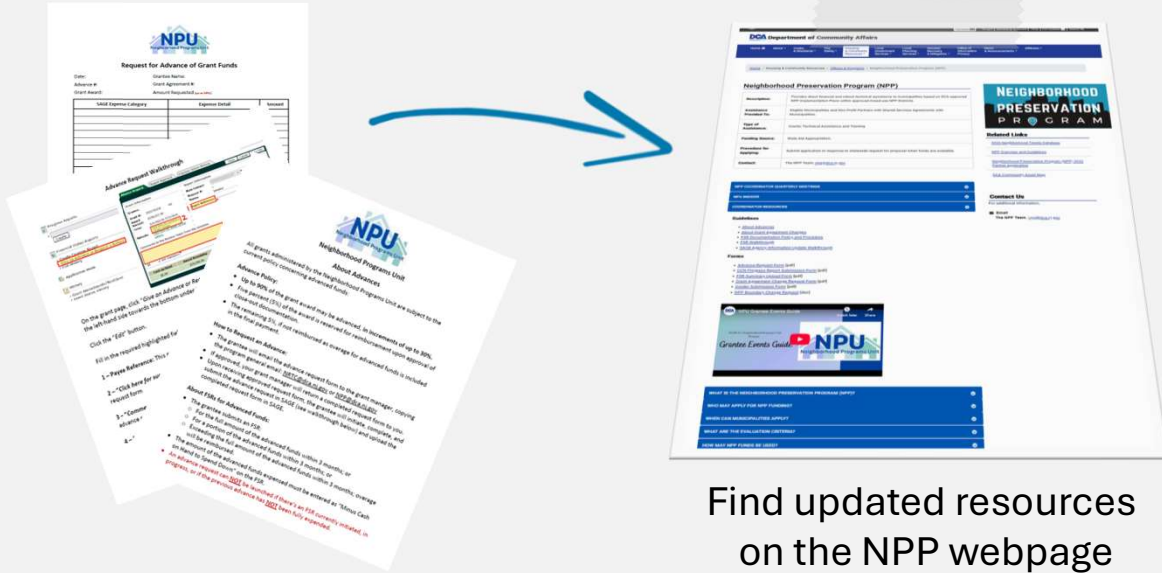

# The Future of NPP



For state fiscal year 2026, \$2.5 million dollars was set aside for the Neighborhood Preservation Program. This will fund the 5<sup>th</sup> and final year for the 20 2022 grantees. The 20 2019 grantees should be aware there are no plans for an RFP for Neighborhood Preservation for 2026. We will meet in the fall to discuss the closeout of those grants.
