Take notice that the Department of Community Affairs (Department) discovered an error in the text of [N.J.A.C. 5:23-3.11](#). Effective April 15, 2013, the Department adopted amendments to Subchapter 4A recodifying [N.J.A.C. 5:23-4A.10](#) to [4A.7](#) (see 45 N.J.R. 6(a); 891(a)). [N.J.A.C. 5:23-3.11\(a\)](#)⁷ contains a cross-reference to [N.J.A.C. 5:23-4A.10](#); upon the recodification of [N.J.A.C. 5:23-4A.10](#) to [4A.7](#), the extant cross-reference was inadvertently made to indicate a "(Reserved)" section. Thus, the cross-reference at [N.J.A.C. 5:23-3.11\(a\)](#)⁷ should be corrected to [N.J.A.C. 5:23-4A.7](#) from 4A.10.

The Department has requested, and the Office of Administrative Law has agreed to, such correction be made administratively. This notice of administrative correction is published pursuant to [N.J.A.C. 1:30-2.7](#).

Full text of the corrected rule follows (addition indicated in boldface **thus**; deletion indicated in brackets [thus]):

SUBCHAPTER 3. SUBCODES

5:23-3.11 Enforcement activities reserved to the Department

All premanufactured systems for Class 1 and Class 2 structures, other than those authorized to be approved by an inplant inspection agency licensed to perform Class 1 and Class 2 plan review as provided in [N.J.A.C. 5:23-4A.10](#) **4A.7**, and all on-site installation of Class 1 and Class 2 premanufactured construction within the jurisdiction of a local enforcing agency that is not a Class 1 or Class 2 agency, as the case may be.
