

Unclaimed Property - Instructions for Local Governments

As noted by the Unclaimed Property Administration (UPA) in the NJ Treasury, “Unclaimed property consists of many types of intangible and tangible properties that have remained unclaimed by its rightful owner for a specific period of time.”

Owners of this unclaimed property include individuals, businesses, and even local government units.

The UPA website provides clear instructions about how to search for a claim, and the whole process only takes a few minutes.

1. Enter City information both as a business name and City. Perform a unique search for all variations (City of Paterson, Paterson, etc.). Click “Search.”

FILE CLAIM

CLAIMANT RELATIONSHIP DESCRIPTIONS:

- Owner:** You are the reported owner of the property listed.
- Heir:** You are the rightful heir or the estate representative for the reported owner who is deceased.
- Legal Representative:** You are legally authorized to function on behalf of the reported owner. (Examples: Power of Attorney, Guardian, Custodian, Trustee)
- Business:** You are the authorized signatory of the business.
- Creditor:** You are the authorized signatory of plaintiff creditor authorized by statute or court order requesting unclaimed property belonging to a debtor.
- Third Party Locator:** You have entered into an agreement with the reported owner and are authorized to assist in the recovery of funds.
