Mr. Bonomo described the history of the conduit bond program, and explained that the List was developed to allow conduit borrowers to select underwriters for their projects.

Aimee Manocchio Nason inquired about the process by which borrowers will select underwriters.

Mr. Bonomo explained that borrowers will identify three candidates from the List, and conduct a straightforward inquiry based on, among other factors, experience in underwriting housing bonds, history with the borrower, if any, and price.

Mr. Bonomo asked if there were any further questions of the Agency.

Monsignor Linder requested a motion to approve the List.

Cathy Boland moved and Stanley Weeks seconded 1. Approval of the Agency's qualified pool of Senior Managing Underwriters for the Conduit Bond Program established pursuant to the Agency's Conduit Bond Program Executive Order No. 26 Policies and Procedures (EO 26 Conduit Procedures).
