Narratives

Program Summary:

The Recovery Housing Program (RHP) authorizes funds to provide stable, temporary housing to individuals in recovery from a substance use disorder (SUD). RHP aims to support individuals in recovery on a path to self-sufficiency and independent living. Data shows that without stable housing, the risk of relapse and inability to maintain abstinence is greatly increased. Recovery houses are necessary to provide individuals recovering from substance use disorders with a safe and supportive place to recover and work towards transitioning back to independent living.

The RHP was authorized under Section 8071 of the Support for Patients and Communities (SUPPORT) Act. To date, the State of New Jersey has received an allocation of \$855,000 and \$1,006,258. The State will use the allowed 5% (\$93,063) for administrative costs and the balance of \$1,768,195 for programmatic activities.

The New Jersey Department of Community Affairs (NJDCA) will work in collaboration with the New Jersey Department of Human Services' Mental Health and Addiction Services (NJ DHMAS) to utilize the federal Recovery Housing Program funds to expand the number of transitional housing units designated for homeless adults or adults who are at-risk of homelessness who have substance use disorders. The funds totaling \$1,768,195 will be used to create at least three (3) new recovery houses; each of which will serve a minimum of five (5) individuals. The residences will provide transitional housing for the participants for 18 to 24 months.

The sober living units must be located in one of the following five counties that have the highest substance abuse admissions rate: Atlantic County, Camden County, Essex County, Monmouth County, and Ocean Counties.



The NJ Department of Community Affairs will be the responsible agency for the overall administration of this program and will use existing staff to administer the program. The funds will be allocated through a Request for Proposal process through the Department's System for Administering Grants Electronically (SAGE). The NJ Department of Human Services will assist in reviewing applications submitted and making awards.

Needs:

Recovery houses are necessary to provide individuals recovering from substance use disorders with a safe and supportive environment to recover and work towards transitioning back to independent living. Research demonstrates that stable housing is a cornerstone to addiction recovery and that people suffering from chronic diseases such as addiction achieve better outcomes when housing accompanied with supportive in-home and community services is provided early on as a basic need. Participants who know they will exit to stable housing are more likely to successfully complete treatment.

The rates of drug abuse and addiction have been steadily climbing in New Jersey. According to the National Institute on Drug Abuse, rates of opioid addiction throughout New Jersey are especially high. In 2018 alone, roughly 90 percent of all reported drug-related overdose deaths in the state were directly linked to opioid narcotics – namely prescription painkillers and heroin. This equated to 2,583 of 2,900 total fatalities.

Use of Funds - Method of Distribution:

The Department of Community Affairs will publish a competitive Request for Proposals on its System for Administering Grants Electronically (SAGE). Successful applicants will use these funds to acquire and if needed minimally rehabilitate a sober recovery residence. The housing created must be licensed as a Class F, Cooperative Sober Living Residence (NJAC § 5:27). Accordingly, individuals will be responsible for providing their own food and taking care of their own laundry. Treatment and counseling may not be provided in the residence; however, non-clinical recovery support services may be provided at the site and the agency may require, at its discretion, drug or alcohol testing of residents. (NJAC § 5:27-2.1).

Use of Funds - Activities Carried Out Directly:

Eligible activities include:

• Acquisition of Real Property. RHP funds may be used for acquisition under 24 CFR 570.201(a) or section 105(a)(1) of the HCD Act (42 USC 5305(a)(1)) for the purpose of providing stable, temporary housing to persons in recovery from a substance use disorder.

• Minor Rehabilitation of Single-Unit Residential. RHP funds may be used for rehabilitation or reconstruction of publicly- or privately-owned single-unit residential buildings and improvements eligible under 24 CFR 570.202(a)(1) or section 105(a)(4) of the HCD Act (42 USC 5305(a)(4)) for the purpose of providing stable, temporary housing for individuals in recovery from a substance use disorder in accordance with Section 8071 and this notice.

• Minor Rehabilitation of Multi-Unit Residential. RHP funds may be used for rehabilitation or reconstruction of publicly- or privately-owned buildings and improvements with two or more permanent residential units that otherwise comply with 24 CFR 570.202(a) and section 105(a)(4) of the HCD Act (42 USC 5305(a)(4)) for the purpose of providing stable, temporary housing for individuals in recovery from a substance use disorder in accordance with Section 8071 and the program notice.

Maximum award is \$600,000 per grantee.

The Request for Proposal (RFP) scoring criteria was developed to include minimum eligibility requirements and to establish priorities, and the weight of criteria for scoring through a point system. The scoring committee will review proposals, prioritize projects, and decide which organizations to fund based on results of the review. A copy of this criteria, outlining what proposals would be scored on and the possible points for each section will be



provided to all organizations during the RFP process.

Substance Use Disorder: the recurrent use of alcohol and/or drugs causing clinically significant impairment, including health problems, disability, and failure to meet major responsibilities at work, school, or home. (Substance Abuse and Mental Health Services Administration)

FFY 2020 and FFY 2021 Projected Outcomes

- Number of new recovery houses created: 3
- Minimum number of bedrooms: 5 per recovery house
- Minimum number of individuals assisted per year: 15
- Minimum number of participants that transitioned into permanent housing: 10

Expenditure Plan:

DCA will comply with all RHP guidelines and expend at least 30% of the funds within year one as required. 100% of RHP funds will be expended prior to the end of the period of performance. Administrative costs will not exceed 5% of the grant. Any program income generated will be used to continue RHP eligible activities. To ensure that 30 percent of RHP funds are expended within twelve months, DCA will issue an RFP within 120 days of the RHP grant agreement with HUD. NJDCA will closely monitor and work with the subrecipients to ensure timely expenditure of funds.



Citizen Participation Summary:

DCA shared the preliminary draft plan with both the Department of Human Services (DHS) and DHS's partner Substance Use Disorder (SUD) agencies. The draft plan was posted on DCA's website on September 1, 2021 for 17 days and a public hearing was held on September 17, 2021. No comments were received.

The Recovery Housing Plan was also discussed at the public hearing held on June 7, 2021 for the State's FY 2021 Annual Action Plan. No comments were received.

Partner Coordination:

The New Jersey Department of Community Affairs will work in collaboration with the New Jersey Department of Human Services' Mental Health and Addiction Services and the current SUD agencies in New Jersey such as Integrity House, John Brooks House, and Freedom House.

New Jersey regulates residential SUD treatment facilities or programs, which means "a facility, or a distinct part of a facility that provides care for the treatment" of SUDs, for 24 or more consecutive hours to two or more clients who are not related to the governing authority or its members by marriage, blood or adoption. This includes facilities that provide residential SUD treatment services to women with dependent children and adult males and/or females. These facilities include:

<u>Halfway houses</u>, which means a residential SUD treatment facility, operating in a physically separate location, in which the halfway house treatment modality is programmatically separate and distinct from short-term or long-term SUD residential services. A halfway house provides SUD treatment designed to assist clients in adjusting to regular patterns of living, engaging in occupational training, obtaining gainful employment and independent self-monitoring and generally approximates ASAM PPC-2R, Level III.1 (low intensity) treatment.

<u>Long-term residential facilities</u>, which means a SUD facility in which treatment is primarily designed to foster personal growth and social skills development, with intervention focused on vocational development are emphasized and generally approximates ASAM PPC-2R, Level III.5 (high intensity, clinically-managed) treatment.

<u>Short-term residential facilities</u>, which means a SUD treatment facility in which treatment is designed primarily to address specific addiction and living skills problems through a prescribed 24-hour per day activity regimen on a short-term basis, and generally approximates ASAM PPC-2R, Level III.7 (medically monitored intensive inpatient treatment) treatment.

<u>Non-hospital-based (medical) detoxification [withdrawal management]</u>, which means a residential SUD treatment facility designed primarily to provide short-term care prescribed by a physician and conducted under medical supervision to treat a client's New Jersey-2 physical symptoms caused by withdrawal from substances, according to medical protocols appropriate to each type of addiction, and generally approximates ASAM PPC-2R, Level 3.7WM (medically monitored inpatient withdrawal management treatment.

Subrecipient Management and Monitoring:

DCA will be responsible for the management and oversight of the program. All sub-grantees will provide monthly status reports on the projects. DCA will provide technical assistance and training for subrecipients to ensure they are fully aware of their responsibilities under the grant.

Pre-Award/Pre-Agreement Costs:

The only costs incurred prior to the grant agreement to be reimbursed are the administrative costs associated with the development, submission, implementation of the RHP Program and Action Plan.

The U.S. Department of Housing and Urban Development (HUD) developed the Recovery Housing Program (RHP) through the response to Federal Register Notice No. FR-6225-M-01 as authorized under Section 8071 of the Support for Patients and Communities (SUPPORT) Act, to support individuals in recovery from a substance use disorder achieve stable housing. Data shows that without stable housing, the risk of relapse and inability to maintain abstinence is greatly increased.

The New Jersey Department of Community Affairs (NJDCA) will work in collaboration with the New Jersey Department of Human Services' Mental Health and Addiction Services (DMHAS) to utilize the federal Recovery Housing Program funds to expand the number of transitional housing units designated for homeless adults or adults who are at-risk of homelessness who have substance use disorders. The Recovery Housing Program funds will be used for the acquisition and/or minor rehabilitation of residential homes that will be licensed through the New Jersey Department of Community Affairs Codes and Standards Office as Class F Cooperative Sober Living Residences. The Recovery Housing Program homes will provide safe, supportive, and stable temporary housing to individuals in active recovery until they obtain permanent housing or for up to 18 to 24 months. The objective will be for 75% of residents to transition into permanent affordable housing upon their exit.

As per the approved Action Plan, the allocation will be utilized to create a new Class F sober living home and administrative costs not to exceed the 5% cap. The units must be located in one of the top five counties that have the highest substance use admission rates. Those counties are Atlantic, Camden, Essex, Monmouth, and Ocean Counties. The home will be designated for individuals who are low-income, homeless or at-risk of homelessness who are in active recovery from a substance use disorder.

The New Jersey Department of Community Affairs will be the responsible agency for the overall administration of this program and will allocate funds to subrecipients through a competitive Request for Proposal process. The Request for Proposals will be administered through the Department's System for Administering Grants Electronically (SAGE) platform. The NJDCA staff will monitor the progress and provide technical assistance to the subrecipient to ensure program goals are met. During the performance period, the NJDCA prepared the draft plan, collaborated with DMHAS, notified the public, then held a public hearing where no comments were received. The NJDCA then submitted the plan to HUD for review and approval. The NJDCA was notified of the award on May 24, 2022, and the grant contracts were signed on June 3, 2022, for the FFY 2020 allocation of \$855,000. Therefore, no activities were completed during the performance period.

As per the approved Action Plan, the allocation will be utilized to create 3 new Class F sober living homes and administrative costs not to exceed the 5% cap. The units must be located in one of the top five counties that have the highest substance use admission rates. Those counties are Atlantic, Camden, Essex, Monmouth, and Ocean Counties. The homes will be designated for individuals who are low-income, homeless or at risk of homelessness who are in active recovery from a substance use disorder. The New Jersey Department of Community Affairs will be the responsible agency for the overall administration of this program and will allocate funds to subrecipients through a competitive Request for Proposal process. NJDCA staff will monitor the progress and provide technical assistance to the subrecipients to ensure program goals are met. The Request for Proposals was administered through the Department's System for Administering Grants Electronically (SAGE) platform.

The Department of Housing and Urban Development (HUD) notified the NJDCA of the award on May 24, 2022, and the grant contracts were signed on June 3, 2022, for the FFY 2020 allocation of \$855,000 and FFY 2021 of

\$1,006,258. The NJDCA combined the FFY 2020 and FFY 2021 allocations for a total of \$1,800,000 in programmatic funds to offer three non- profit agencies up to \$600,000 to create three new Class F transitional recovery residences. Of the \$1,861,258 combined award, the NJDCA allocated \$61,258 for administrative costs, comprised of \$10,945.10 from FFY2020 and \$50,312.90 from FFY 2021, which is under the 5% cap.

During the performance period, the Request for Proposal process was completed within the 120-day period. However, despite outreach attempts and collaboration with DMHAS, only three agencies applied. All three agencies were non-profit agencies that had prior experience with housing and serving individuals with substance use disorders.

The subrecipient awards have not been executed in this performance period but are expected to be completed in the beginning of the following performance period. The NJDCA will meet the 30% expenditure deadline due to the high upfront costs of acquiring properties for the creation of new transitional sober living houses.

The Recovery Housing Program (RHP) authorizes funds to provide stable, temporary housing to individuals in recovery from a substance use disorder. RHP aims to support individuals in recovery on a path to self-sufficiency and independent living. Data shows that without stable housing, the risk of relapse and inability to maintain abstinence is greatly increased. Recovery houses are necessary to provide individuals recovering from substance use disorders with a safe and supportive place to recover and work towards transitioning back to independent living.

The RHP as authorized under Section 8071 of the Support for Patients and Communities (SUPPORT) Act. In federal fiscal year 2022, the State of New Jersey received \$1,008,572. The State will use the allowed 5% (\$50,428) for administrative costs and the balance of \$958,144 for programmatic activities. The funds totaling \$958,144 will be used to create at least one (1) new recovery house, which will serve a minimum of five (5) individuals. The residences will provide transitional housing for the participants for 18 to 24 months while they look for permanent housing.

The sober living unit must be located in one of the following 10 counties that have the highest substance abuse admissions rate: Atlantic, Burlington, Camden, Essex, Gloucester, Hudson, Middlesex, Monmouth, Ocean, and Passaic counties.

As per the approved Action Plan, the allocation from FFY 2020 and FFY 2021 will be utilized to create 3 new Class F sober living homes in one of the top five counties, (Atlantic, Camden, Essex, Monmouth, or Ocean County), that have the highest substance use admission rates.

Due to the lack of competition at the Request for Proposal level for the prior year, the NJDCA modified the Action Plan for the FFY 2022 funding to expand the service area to include the top ten counties with the highest substance use admission rates. This change went out for public comment, but none were received. It was then approved in the Action Plan by HUD. The service area now includes Atlantic, Burlington, Camden, Essex, Gloucester, Hudson, Middlesex, Monmouth, Ocean, and Passaic counties. The FFY 2022 funds will be utilized for the acquisition and minor rehabilitation of one additional Class F transitional sober living residences and the remaining funds will be utilized with a future allocation for additional units. All the transitional sober living residences will be designated for individuals who are low- income, homeless or at-risk of homelessness who are in active recovery from a substance use disorder.

On May 24, 2022, the Department of Housing and Urban Development (HUD) notified the NJDCA of the recovery housing awards and the grant contracts were signed on June 3, 2022, for the FFY 2020 allocation of \$855,000 and FFY 2021 of \$1,006,258. The NJDCA combined the FFY 2020 and FFY 2021 allocations for a total of \$1,800,000 in programmatic funds to offer three non-profit agencies up to \$600,000 to create three new Class F transitional recovery residences. Of the \$1,861,258 combined award, the NJDCA allocated \$61,258 for administrative costs, comprised of \$10,945.10 from FFY 2020 and \$50,312.90 from FFY 2021, which is under the 5% cap.

The FFY 2020 and FFY 2021 programmatic funding were allocated to three subrecipients for each to acquire and do minor rehabilitation activities in order to create new Class F transitional sober living residences. There was a delay from when the RFP closed until grant awards were completed due to the project feasibility of the three applications. After a consultation with DMHAS, it was determined no other applicants were likely to apply if the RFP time was extended. Therefore, NJDCA staff provided program guidance and additional time for applicants to find eligible and conforming projects.



During the performance period, NJDCA expended 98% of the FFY 2020 allocation totaling \$835,840.37 of the \$855,000 in funding. For the FFY 2021 allocation, 76% of the grant award totaling \$768,463.10 of \$1,006,258 has been expended. The 30% expenditure deadline has been met for both funding years. The subrecipients have been reimbursed for the acquisition costs but the NJDCA has been having technical difficulties in the Disaster Recovery Grant Reporting System (DRGR) and has not been able to draw down the funds or submit the updated Action Plan. The NJDCA has submitted an AAQ but has not had a resolution to the problem, therefore in DRGR, the draw downs and projects do not reflect the program progress.

For the first project, TEAMS Management 2000 was allocated \$600,000 of FFY 2021 funding. The project was broken down into two activities: acquisition of \$454,238 and minor rehabilitation of \$145,762. The agency acquired a fivebedroom home on a double lot in Irvington, New Jersey in April of 2023. The agency has expended \$454,238 in acquisition costs for this project however it has not been reflected in DRGR at this time due to technical issues. The agency is currently working with the township tax office regarding their non-profit status prior to starting the rehabilitation work. Once completed, the project will provide transitional housing for five low-income individuals in early recovery from a substance use disorder for up to 24 months. There are no occupants during this performance period but once occupied the project will further the LMC national objective.

For the second project, The United Community Corporation was allocated \$600,000 which was a combination of FFY 2020 and FFY 2021 funding. The project was broken down into two activities: acquisition of \$558,250 and minor rehabilitation of \$41,750. In May of 2023, the agency acquired the mixed-use building that had originally been a large single-family home but was converted by prior owners into a commercial space on the first floor and two apartments on the second and third floors. The prior use was non-conforming as a mixed-use building for that zone. The agency had received support from the local township prior to purchasing the home and is going through the process to obtain zoning approval for the sober living residence. After the zoning approval is received, they will start the minor rehabilitation activity which will occur in the next performance period. The agency has expended \$558,250 in RHP acquisition costs for this project however it has not been reflected in DRGR at this time due to technical issues. Once completed, the project will provide transitional housing for five low-income individuals in early recovery from a substance use disorder for up to 24 months. There are no occupants during this performance period but once occupied the project will further the LMC national objective.

For the third project, Garden State Homes was allocated \$600,000 of FFY 2020 funding. The project was broken down into two activities: acquisition of \$581,296 and minor rehabilitation of \$18,704. Garden State Homes provides services in Monmouth County which is along the Atlantic Ocean. The agency had difficulties identifying a property that would provide residents with access to transportation and employment, had sufficient size to accommodate six bedrooms, and could pass the Environmental Review. As with many coastal areas, many of the residential homes were located in a flood plain or coastal hazard area. The first viable property could not get municipal support for zoning. In addition to those limitations, the housing market was very competitive statewide which made it difficult to identify sellers who would agree to conditional sales pending the completion of an environmental review. Fortunately, the agency was able to identify a recently renovated 5-bedroom home in Cliffwood, New Jersey that had multiple common spaces. The agency acquired the home in September 2023 for \$581,296.21. The minor rehabilitation activities are limited to converting an extra living space into a bedroom and minor repairs. The minor rehabilitation process will occur in the next performance period. Once completed, the project will provide transitional housing for five low-income individuals in early recovery from a substance use disorder for up to 24 months. There are no occupants during this performance period but once occupied the project will further the LMC national objective.

The NJDCA staff will continue monitoring the progress of these three projects to ensure timely implementation with a goal of terminating the minor rehabilitation activities and becoming operational by September 30, 2024.

The NJDCA received the FFY 2022 award of \$1,008,572 on March 29, 2023, and the grant was executed on April 14, 2023. The NJDCA has allocated \$50,428.60 of the funding for administrative costs which is in compliance with the 5% cap. The remaining \$958,143.40 will be used to create additional sober living residences. The NJDCA has plans to release a new RFP for \$650,000 to support the acquisition and minor rehabilitation of one new transitional recovery house residence. There have been internal delays within the NJDCA as the primary staff member for this program retired in April 2023. Two staff members are now working to ensure compliance and move the FFY 2022 and future funding forward. The NJDCA hopes to release an RFP shortly for the FFY 2022 funding.

The Recovery Housing Program (RHP) was authorized under Section 8071 of the Support for Patients and Communities (SUPPORT) Act. In June 2022, the State of New Jersey received two allocations, one for FFY 2020 for \$855,000 and one for FFY 2021 for \$1,006,258. In order to increase the number of units in the competitive housing market and to address a shortfall an agency experienced due to increase dminor rehabilitation costs; the State shall not use the full 5% in administrative costs allowed (\$93,063). After a demonstrated need by an agency, the State shall only utilize \$10,945.10 in administrative costs to allow for \$1,850,312.90 for programmatic activities.

In Federal Fiscal Year (FFY) 2023, the State of New Jersey received \$1,072,304. The State will use the allowed 5% (\$53,615.20) for administrative costs and the balance of \$1,018,688.80 for programmatic activities. The funds totaling \$1,018,688.80 will be used to create at least two (2) new recovery houses; each of which will serve a minimum of five (5) individuals. The residence will provide transitional housing for the residents for 18 to 24 months. The sober living units must be in one of the following 10 counties that have the highest substance abuse admissions rate: Atlantic, Burlington, Camden, Essex, Gloucester, Hudson, Middlesex, Monmouth, Ocean, and Passaic counties.

For the Federal Fiscal Year 2024, HUD approved the Action Plan to create at least one (1) new recovery house, which will serve a minimum of 5 individuals. The residence will provide transitional housing for the participants for 18 to 24 months. The sober living units must be in one of the following 9 counties that have the highest substance abuse admissions rate: Atlantic, Camden, Essex, Gloucester, Hudson, Middlesex, Monmouth, Ocean, and Passaic counties. These figures are based on the New Jersey Department of Human Services 2022 Substance Abuse Overview.

As per the approved Action Plan, the allocation from FFY 2020 and FFY 2021 is being utilized to create 3 new Class F sober living homes in one of the top five counties that have the highest substance use admission rates. The FFY 2022 and FFY 2023 allocations are being utilized to create an additional 3 new Class F sober living residences in one of the top ten counties with the highest substance use admission rates. The NJDCA previously expanded the eligible service area after the first round of Request for Proposals. The NJDCA Action Plan was approved for the FFY 2024 funding which identifies the top nine highest substance use counties as the service area which consists of Atlantic, Burlington, Camden, Essex, Gloucester, Mercer, Middlesex, Monmouth, Ocean and Passaic counties per the NJ Department of Human Services 2023 Substance Use Overview Report.



Between the four funding years, the NJDCA is planning to acquire and do minor rehabilitation to create six new transitional sober living residences which will each house at least five residents therefore creating thirty new beds. To qualify for eligibility, the residents must be low-income, homeless or at risk of homelessness, in early recovery from a substance use disorder and be actively seeking services for recovery.

The FFY 2020 and FFY 2021 programmatic funding were allocated to three subrecipients. The agencies acquired the three residential homes in the prior performance period and have been working to complete the minor rehabilitation in order to get the home prepared for occupancy. During the performance period, NJDCA performed site visits for all three properties. One of the agencies has had significant expenditures beyond the original award of \$600,000. As a result, the NJDCA has increased the subrecipient's allocation to \$650,312.90 by relinquishing administrative costs from FFY 2021 totaling \$50,312.90.

The NJDCA was able to successfully submit the amended Action Plan and get access to the Disaster Recovery Grant Reporting System (DRGR) after significant delays. NJDCA submitted multiple AAQs and worked with the IT team to troubleshoot the technical difficulties for over six months before it was rectified. The NJDCA met the 30% expenditure deadline on the FFY 2020 and FFY 2021 funding and was able to set up the projects and activities in DRGR. Now that the technical issues with DRGR have been resolved, NJDCA has been submitting drawdowns for the associated projects to demonstrate the program progress.

The NJDCA received the FFY 2022 allocation of \$1,008,572 on April 14, 2023, and had planned to release the RFP for the project sooner. The NJDCA ended up combining the FFY 2023 allocation of \$1,072,304 received on February 22, 2024, with the FFY 2022 to release a combined RFP for both funding years. The Request for Proposals totaled \$1,957,000 in programmatic funds to create three additional Class F sober living residences. The NJDCA reserved 5% of the grant award for administrative costs, \$50,428 for FFY 2022 and \$53,615 for FFY 2023, which is within the 5% cap. The NJDCA met with HUD representatives to discuss the progress of the Recovery Housing Program and get guidance on DRGR.

For the FFY 2022 and FFY 2023, the three subrecipient contracts were awarded on September 1, 2024. The three agencies are actively working with NJDCA staff to identify residential homes that are appropriately zoned, sized, and can pass the environmental review. The NJDCA will meet the 30% expenditure deadline for the FFY 2023 funding. The NJDCA has been working with HUD to demonstrate progress and is now updating DRGR accordingly.

In February 20he ageny will renovate t24, the subrecipient had the architectural drawings completed to convert the space. Due to the high acquisition costs relative to the grant award, the agency had limited RHP funding for minor rehabilitation and was expending agency capital funds for the majority of the minor rehabilitation costs to convert the home. When the subrecipient indicated the property was ready to apply for the Class F license and the work was complete, the NJDCA staff went for a site visit. The NJDCA staff found the site did not reflect the architectural drawing returning the building to a single-family home and had an insufficient number of bedrooms for the RHP program. In that configuration, the building would not qualify for a Class F license. In order to help facilitate the success of the project, the NJDCA reallocated \$50,312.90 in administrative costs to the agency for minor rehabilitation activities to help complete the project. The agency and NJDCA are in regular communication to monitor the progress. Once completed, the project will provide transitional housing for five low-income individuals in early recovery from a substance use disorder for up to 24 months or until they obtain permanent housing. There are no occupants during this performance period but once occupied the project will further the LMC national objective.
