## 1. Introduction

The Committee recently convened to discuss initiatives and make decisions crucial to advancing the aims of the task force. This memo summarizes the discussions, presentations, and decisions made during the meeting. The meeting was brought to order and the public notice was read aloud.

#### 2. Application and Membership Updates

• Clarification was sought regarding the subcommittee membership application process. It was affirmed that task force seats are appointed, while subcommittee memberships are open for applications from interested parties.

#### 3. Subcommittee Flowchart

- A flowchart with the newly formed subcommittee names and vision statements was presented to the task force for approval.
- Voting procedures were executed to ascertain consensus on new committee structures and initiatives. There was unanimous support among members.

### **SORS** report Overview

- Outlined the four pillars model of the report and detailed the focuses of each pillar.
- Areas that were not studied in this report were listed.
- The task force was asked to review the draft of the SORS report and respond with comments, questions, or suggested edits.

### Development and Fundraising Subcommittee and Children's Trust Fund update

- A detailed review of the past fiscal year's expenditures was conducted, noting significant
  allocations towards initiatives such as the Fatherhood Engagement Initiative and the Predict
  Align Prevent effort.
- Past investments have resulted in valuable insights which are informing future strategic directions.
- Efforts will be augmented by new stakeholders from diverse sectors, including philanthropic partners and fiscal strategists.

### **National Trust Fund Initiatives**

• Insights into successful models from other states including New York and Ohio were shared.

#### **Problematic Sexualized Behavior Work Group**

- Problematic Sexual Behavior Program Framework: Ongoing efforts to address issues related to minors' sexual behaviors were highlighted. The referral process was outlined as well as the training of treatment providers.
- Funding in the following areas was provided by the Department of Children and Families.
  - Specialized Care Coordinator positions
  - Child Treatment Assistance Fund
  - > PBS Program Staff and related program expenses.
  - Training
- Presentation outlining preliminary data review.

### **Fall Conference update**

- The conference is at full capacity, including participants from law enforcement, educational and medical settings.
- The agenda has been set to include a presentation by keynote speaker, Dr. Jessica Pryce.
- The main topic will be mandatory reporter requirements. The conference seeks to enhance
  effectiveness and awareness in child neglect and abuse reporting to render improved outcomes
  in child protection interventions.

#### Conclusion

• The dedicated efforts of all members to uphold the mission of strengthening family and children's services in New Jersey were acknowledged.
