**1. Partnership with Montclair State University:**

- An agreement between the Department of Children and Families (DCF) and Montclair State University has been executed for an 18-month period. This partnership focuses on leveraging Montclair's extensive expertise in child welfare across New Jersey and the

United States to enhance operational recommendations and drafting of the annual report.

**2. Data Management and Reporting:**

- Montclair State University has taken initial steps towards the integration of data between Montclair University and the Camden Coalition. The necessary access to data is expected to facilitate a statutorily required report to the Governor's office and the Legislature.
- The committee noted a delay in data examination which arose due to a transition in contractual responsibilities from the previous agreement with Camden Coalition to the new agreement with Montclair University. and the potential impact on future reporting timelines. A target review of readiness for the December report should be projected by June.

**3. Presentation by the Office of Analytics and System Improvement:**

- Data detailing referrals to the hotline was outlined in this presentation. Members requested clarification on how the definition of a “caregiver” impacts this data.
- The use of predictive response models in other states was discussed.

**4. Child Welfare and Case Practice Implementation:**

- Discussions highlighted the interest of members to better understand the impact of solution-based case practices. Emphasis was placed on reviewing the existing impact that these changes have had on staff practice and identifying areas for further development.
- The committee considered a future survey to gather detailed feedback on the case practice model implementation. The planning for this survey is ongoing, with an emphasis on utilizing existing data collection frameworks.

**5. Operational Adjustments:**

- A decision was reached to adjust future meeting start times to 2:30 PM to better accommodate participants. This time change is intended to prevent conflicts with typical closing hours and to facilitate full participation.

**Decisions Made:**

- Approval of the previous meeting's minutes was confirmed with no amendments required.
- A motion to integrate learnings from the partnership with Montclair into our community engagement practices was ratified unanimously.

**Next Steps:**

- Initiate detailed collaboration discussions between Montclair State University and the Camden Coalition to streamline data integration.

- Plan necessary adjustments to projected timeline to prepare the report for the Governor's office and Legislature.
- Set up a working group to define the survey framework focusing on solution-based case practice improvements.

**Conclusion:**

These strategic decisions and conversations represent pivotal advancements toward improving service delivery and operational efficiency within our community. The committee remains committed to leveraging partnerships and data-driven decisions to enhance child welfare outcomes.
