1. Approval of Previous Minutes:

• Previous meeting minutes were reviewed and approved without amendments after a motion was made and seconded by committee members.

2. Reports from Subcommittees:

- Legislation and Policy Workgroup:
 - Reviewed legislative comparisons between current bills in the State Senate and Assembly; S3485/Bucco and S3054/Gopal assessing penalties and other regulatory measures.

- S3485/Bucco: Revises law requiring school districts, charter schools, nonpublic schools, and contracted service providers to review employment history of prospective employee for allegations of child abuse or sexual misconduct.
- S3054/Gopal: "Safer Students Act"; requires school districts, charter schools, nonpublic schools, contracted service providers, and institutions of higher education to review employment history of prospective employee for allegations of child abuse or sexual misconduct.
- Discussion on the engagement with legislative sponsors for further analysis and potential advocacy.
- Education and Training Work Group:
 - Presented a drafted communication guide intended to standardize dialogue with educational districts.
 - Reported on ongoing efforts to evaluate and improve professional development standards.
 - Collected and discussed committee feedback on communication with school districts and the proposed standardized conversation approach. Members offered comments on possible ways to proceed.
