Robert Kettig, New Jersey Department of Environmental Protection

Bob Kettig is currently Bureau Chief of the Bureau of Energy and Sustainability at The New Jersey Department of Environmental Protection. In his 28-year career at NJDEP, Bob has worked in a number of programs that have included managing the Air Permitting Program, serving as DEP Representative for the Regional Greenhouse Gas Initiative (RGGI) and overseeing stack emission monitoring testing with The Bureau of Technical Services.
