The New Jersey Department of Environmental Protection's Division of Sustainable Waste Management, Bureau of Solid Waste Planning and Licensing is in receipt of a request for administrative action to the Atlantic County District Solid Waste Management Plan (County Plan) dated January 27, 2025. This request proposes plan inclusion of designated truck routes for the Waste Management of New Jersey, Inc. Buena Vista Transfer Station/Materials Recovery Facility (TS/MRF) located on Block 606, Lot 1, Block 607, Lot 1, and Block 608, Lot 1 in the Township of Buena Vista. The January 27, 2025 request included a map entitled "Atlantic County Solid Waste Truck Route Map, WMNJI Buena Vista Transfer Station/MRF, Block 606, Lot 1; Block 607, Lot 1 & Block 608, Lot 1, Buena Vista Township, Atlantic County, New Jersey", prepared by Marathon Engineering & Environmental Services, dated January 24, 2025, which illustrated all designated truck routes.

Pursuant to N.J.A.C. 7:26-6.11(b)2, the inclusion of designated traffic routes for solid waste vehicles accessing a solid waste facility can be accomplished via administration action. Therefore, the County Plan inclusion of designated truck routes for solid waste vehicles accessing the Waste Management of New Jersey, Inc. Bureau Vista TS/MRF is hereby approved as an administrative action pursuant to N.J.A.C. 7:26-6.11.
