The New Jersey Department of Environmental Protection's Division of Sustainable Waste Management, Bureau of Solid Waste Planning and Licensing is in receipt of a request for administrative action to the Cumberland County District Solid Waste Management Plan (County Plan) dated April 14, 2025. This request for administration action to the County Plan proposes County Plan inclusion of the acceptance of additional recyclable materials and the inclusion of hours of operation at the Dragon Recycling, LLC Class B Recycling Center located at 1020 Buckshutem Road (Block 24, Lot 26) in the Township of Fairfield. Specifically, the administrative action requests the inclusion of leaves and painted and non-painted pallet wood and identifies the hours of operation for receiving, storing, transferring, and processing Class B recyclable materials as 7:00 a.m. to 9:00 p.m., Monday through Saturday. This request will not result in any additional operational changes at the facility which is currently included in the County Plan to accept up to 350 tons per day of asphalt, concrete, brick, and block and up to 50 tons per day of trees, tree trunks, tree parts, tree stumps, brush, and untreated wood and pallets.

Pursuant to <u>N.J.A.C.</u> 7:26-6.11(b)14, the inclusion of hours of operation can be accomplished via administrative action. Pursuant to <u>N.J.A.C.</u> 7:26-6.11(b)5, the inclusion of the acceptance of additional recyclable materials can be accomplished via administrative action. Therefore, the County Plan inclusion of hours of operation and additional recyclable materials at the Dragon Recycling, LLC Class B Recycling Center is hereby approved as an administrative action pursuant to <u>N.J.A.C.</u> 7:26-6.11.
