The New Jersey Department of Environmental Protection's Division of Sustainable Waste Management, Bureau of Solid Waste Planning and Licensing is in receipt of a request for administrative action to the Gloucester County District Solid Waste Management Plan (County Plan) dated February 28, 2025. This amendment to the County Plan proposes County Plan inclusion of a change in name for the Bioenergy Devco, LLC Class C Recycling Center, located at 107 Gilbreth Parkway in the Township of Mantua, to BTS Bioenergy Mantua, LLC. This request proposes to include a change in block and lot designation from Block 261, Lots 3, 9.02, and 10 in the Township of Mantua and Block 1, Lots 4 and 5 in the Township of Harrison to Block 261, Lots 7.01, 8, 11.01 and 11.02 in the Township of Mantua and Block 1, Lot 10 in the Township of Harrison. This request proposes to include hours of operation for this facility to receive food waste as 6:00 a.m. to 7:00 p.m., Monday through Saturday, and Sunday from 6:00 a.m. to 1:00 p.m. The facility is currently included in the County Plan as operating 24 hours a day, Monday-Sunday, for processing food waste, which will not change.

Pursuant to <u>N.J.A.C.</u> 7:26-6.11(b)14, the inclusion of hours of operation, revised block and lot designation, and a change in name can be accomplished via administrative action. Therefore, the County Plan inclusion of hours of operation, revised block and lot designation, and change in name from Bioenergy Devco, LLC to BTS Bioenergy Mantua, LLC is hereby approved as an administrative action pursuant to <u>N.J.A.C.</u> 7:26-6.11.
