The New Jersey Department of Environmental Protection's Division of Sustainable Waste Management, Bureau of Solid Waste Planning and Licensing is in receipt of a request for administrative action to the Ocean County District Solid Waste Management Plan (County Plan) dated March 3, 2025. This amendment to the County Plan proposes County Plan inclusion of the address, hours of operation, authorized recyclable materials, and daily throughput capacity for the Ocean County Recycling Center, Inc. Class B Recycling Facility. This request proposes to confirm the facility's address as 1497 Lakewood Road, Block 410, Lot 26, in the Township of Toms River, formerly known as the Township of Dover. This facility's hours of operation are 7:00 a.m. to 5:00 p.m., Monday through Friday, and 7:00 a.m. to 12:00 p.m. on Saturdays. This facility is authorized to accept asphalt, concrete, brush, trees, tree parts, tree stumps, unpainted and non-chemically treated wood, and tires, with or without rims, with a maximum daily throughput capacity of 670 tons per day.

Pursuant to N.J.A.C. 7:26-6.11(b)5, the inclusion of authorized recyclable materials can be accomplished via administrative action. Pursuant to N.J.A.C. 7:26-6.11(b)14, the inclusion of a facility's address, hours of operation, and daily throughput capacity can be accomplished via administrative action. Therefore, the County Plan inclusion of authorized recyclable material, address, hours of operation, and daily throughput capacity at the Ocean County Recycling Center, Inc. Class B Recycling Facility is hereby approved as an administrative action pursuant to N.J.A.C. 7:26-6.11.
