The Department of Environmental Protection's Division of Solid and Hazardous Waste is in receipt of a request for administrative action to the Passaic County District Solid Waste Management Plan (County Plan) dated May 9, 2017. Administrative Action 002-17 to the County Plan proposes County Plan inclusion of the name change of the Tilcon of New Jersey Class B Recycling Center to PPark NJ, LLC, and the inclusion of additional parcels. Specifically, Administrative Action 002-17 to the County Plan proposes County Plan inclusion of the following parcels:


- o Block 13; Lot 9
- o Block 14; Lot 1
- o Block 15; Lot 1
- o Block 16; Lot 8
- o Block 21, Lot 9
- o Block 27; Lot 39
- o Block 67; Lot 5
- o Block 73; Lot 51
- o Block 83; Lot 1
- o Block 93; Lot 1

Pursuant to N.J.A.C. 7:26-6.11(b)14, the inclusion of a change in name of an existing recycling center can be accomplished via an administrative action. Pursuant to N.J.A.C. 7:26-6.11(b)5, the inclusion of additional parcels of land to an existing recycling center can be accomplished via an administrative action. Therefore, the County Plan inclusion of the change in name of Tilcon of New Jersey to PPark NJ, LLC and the inclusion of the above identified parcels is hereby approved as an administrative action pursuant to N.J.A.C. 7:26-6.11(f).

However, in review of the history of this facility in the County Plan, deficiencies were found. The County is hereby directed to submit to the Department within 60 days of the date of this signed document the daily tonnage of Class B materials to be accepted at the facility and the revised hours of operation. This may be accomplished through an Administrative Action pursuant to N.J.A.C. 7:26-6.11.
