Dear Ms. Seiden:

The Department of Environmental Protection's Division of Solid and Hazardous Waste is in receipt of a request for administrative action to the Passaic County District Solid Waste Management Plan (County Plan) dated June 30, 2016. Administrative Action 001-16 to the County Plan proposes County Plan inclusion of designated traffic routes for solid waste vehicles accessing the Gaeta Recycling Company, Inc. Transfer Station/Materials Recovery Facility (TS/MRF), located at 278-282 West Railway Avenue and the Class A Recycling Center, located at 189-195 Genessee Avenue, both in the City of Paterson. Specifically, the June 30, 2016 request for administrative action to the County Plan proposed County Plan inclusion of three traffic routes for solid waste vehicles accessing the facility:

1. In-bound waste vehicle traffic from Crook's Avenue turn onto West Railway Avenue. All in-bound trucks are directed to one of two scales. From the scales, the vehicles are directed to tipping area entrances either along West Railway Avenue or will be directed westerly on Vesper Street to Getty Street, then south to Genessee Street. Facility staff will direct traffic as vehicles enter and exit at all facility entrances.
2. Traffic from I-80 east bound will travel on Pennsylvania Avenue to Gould Avenue and then turn left onto West Railway Avenue. When the facility is reached, traffic is managed as described above.
3. Traffic from I-80 west bound will travel to Madison Avenue to Getty Street, then turn on Vesper Street and will continue to West Railway Avenue. At the facility, the traffic is managed as described above.

Pursuant to N.J.A.C. 7:26-6.11(b)2, the inclusion of designated traffic routes for solid waste vehicles accessing a solid waste facility can be accomplished via an administrative action. Therefore, the County Plan inclusion of designated traffic routes for solid waste vehicles

accessing the Gaeta Recycling Company, Inc. TS/MRF and Class A Recycling is hereby approved as an administrative action pursuant to N.J.A.C. 7:26-6.11(f).
