Dear Ms. Seiden:

The Bureau of Planning & Licensing is in receipt of an administrative action to the Somerset County District Solid Waste Management Plan ("County Plan"), dated August 27, 2021. Administrative Action 001-21 to the County Plan proposes County Plan inclusion of revised hours of operation and designated truck routes for solid waste vehicles entering and exiting the Skytop Recycling, Inc. Transfer Station/Materials Recovery Facility ("TS/MRF"), located on Block 6002, Lot 34, 80 Airport Road in the Township of West Milford.

The revised hours of operation will be:

Monday – Friday:	6:00 am to 3:30 pm
	for Waste Acceptance/Processing/Loading
Monday – Friday:	3:30 pm to 6:00 pm
	for Waste Processing/Maintenance/Loading
Saturday:	6:00 am to 12:00 pm
	for Waste Acceptance/Processing/Loading

Additionally, designated truck routes are as follows:

- Collection vehicles entering Passaic County will utilize two routes as follows:
  - Trucks will drive north/west from State Route 23 onto Greenwood Lake Turnpike (County Route 511) to Marshall Hill Road (County Route 696) to Airport Road (local street) to the facility.
  - Trucks will drive north/east from State Route 23 onto Union Valley Road (County Route 513) to Marshall Hill Road (County Route 696) to Airport Road (local street) to the facility.

- Residue trucks' destination leaving Passaic County will be Keystone Landfill in Pennsylvania, therefore trucks will leave the facility, drive north into New York State, and then west to Pennsylvania. The two routes are as follows:
  - Trucks will drive northwest on Greenwood Lake Turnpike, then north on Warwick Turnpike to New York State. This would designate that trucks make a left turn from Marshall Hill Road onto Greenwood Lake Turnpike.
  - Trucks will drive northeast on Greenwood Lake Turnpike to Margaret King Avenue, and then the remainder of the route on Mill Pond Road to New York State.

Pursuant to <u>N.J.A.C.</u> 7:26-6.11(b)14, the inclusion of revised hours of operation can be accomplished via an administrative action. Pursuant to <u>N.J.A.C.</u> 7:26-6.11(b)2, the inclusion of designated traffic routes for solid waste vehicles accessing a solid waste facility can be accomplished via an administrative action. Therefore, the County Plan inclusion of revised hours of operation and designated traffic routes for solid waste vehicles accessing the Skytop Recycling, Inc. TS/MRF, is hereby approved as an administrative action pursuant to <u>N.J.A.C.</u> 7:26-6.11(f).
