NJDEP Adopts Correction to Air Minor Source Grace Period Determination

Who is affected by this correction?

Gasoline dispensing facilities that are required to perform vapor recovery testing.

What changed?

The New Jersey Administrative Code, N.J.A.C. 7:27-16.3(i)1, requires Static Pressure Performance, Pressure/Vacuum Valve, Dynamic Backpressure, and Air/liquid volume ratio testing at gasoline dispensing facilities.

A violation of N.J.A.C. 7:27-16.3(i)1 would be a failure to demonstrate, through testing, that the facility's vapor control system is performing properly. If the vapor control system is not working properly, emissions would not be detected. Failure to detect emissions undermines and impairs the goals of the Department's Air Quality Program, therefore, making such a violation ineligible for designation as a Minor violation under the Grace Period Law, N.J.S.A. 13:1D-129.b(3).

This advisory provides notice that the Department has recently amended the Air Administrative Procedures and Penalties Code, N.J.A.C. 7:27A-3.10(m)16, to correct the designation of the type of violation from "Minor" to "Non-Minor."

What should I do?

- Carefully adhere to your required tests and testing schedule in accordance to the conditions of your Air Permit and/or the requirements of N.J.A.C. 7:27-16.3.
- Consider putting your station or facility on an automatic vapor recovery testing schedule.
- Have your test results ready for inspection at the facility.
