SPECIAL NON-RESIDENT LICENSE DOCUMENTATION FORM

New Jersey makes the purchase of hunting and trapping licenses, and rifle permits, available through its Internet License site and the new Integrated Electronic Licensing System (IELS). To make a purchase on the site, customers must first provide proof of a previous year’s license, rifle permit or hunter education course completion. This form is designed for that purpose. **However, for the Division of Fish and Wildlife (DFW) to process this form it is necessary for you to first visit the license Web site at www.nj.wildlifelicense.com/ and create a customer record and be assigned a lifetime Conservation ID Number (CID#).**

Non-residents seeking a hunting license, trapping license, or rifle permit have two methods by which they may “unlock” the option to purchase their first license using the IELS.

OPTION 1	<p>You may obtain your hunting/trapping license or rifle permit at any of the DFW’s 200 authorized agents when you visit New Jersey. A list of agents is available in the free New Jersey Fish and Wildlife Digest or by visiting www.njfishandwildlife.com/agentlst.htm on the DFW Web site. There are no additional fees for visiting a license agent.</p>
OPTION 2	<p>You may obtain your hunting/trapping license or rifle permit by using the DFW’s new Internet sales site (www.nj.wildlifelicense.com/). In order to unlock a hunting/trapping license or rifle permit on the Internet sales site, you must first fax, e-mail scanned copies, or mail the following items to the DFW:</p> <ul style="list-style-type: none"> • <i>Signed copy of this application form.</i> • <i>Copies of the appropriate resident license/hunter education cards.</i> <p>This documentation will only have to be sent to the DFW for the first Internet purchase of each license type.</p> <p>Preferred Method: <i>Please e-mail copies of this signed application, along with copies of the appropriate license(s) or hunter education card(s) to njhuntered@dep.nj.gov. Please title the e-mail “Non-Resident Hunting License Documentation.”</i></p> <p>Optional Method: <i>Please fax copies of this signed application, along with copies of the appropriate license(s) or hunter education card(s) to (856) 629-5044 Attention: Hunter Education</i></p> <p>NOTE: If the scanned or faxed copies are not legible you will be required to mail this signed application and copies of the appropriate licenses or hunter education card.</p> <p>The DFW will update your customer record to allow you to purchase the hunting license(s) you qualify for and notify you that the update has been completed. Once your record is updated you may visit the Internet sales site and purchase your license(s). There is a shipping and handling fee for some (not all) items purchased using the Internet sales site.</p>
