We will follow-up with pledged marinas shortly and contact facilities to schedule a three-year recertification visit in the next few months.

We are also in the process of planning a roundtable session for pledged marinas in the coming months.

NJDEP Announces Ecologically Sensitive Areas in Barnegat Bay

The New Jersey Department of Environmental Protection has identified Ecologically Sensitive Areas in Barnegat Bay that are home to a diverse group of fish, wildlife, and habitats and provide shelter and feeding grounds for a number of important local species. Posters have been distributed to marinas, bait and tackle shops, and boat ramps in the Barnegat Bay region with a map of these important areas and a list of actions boaters can take to help keep the Bay healthy.

Basic Industrial Stormwater Permit Renewal

The NJDEP Basic Industrial Stormwater General Permit (5G2) required for marinas has expired. An updated draft permit has been created; most of the changes are minor and are limited primarily to changes in language and updates for facilities applying for the first time.

The NJDEP will be providing marinas that currently have this permit with a notification letter about where to view the draft permit. An information update sheet and a form asking if permit holders would like to renew electronically (the permit and accompanying documents would be sent via email to reduce paper mailings) will be provided with the notification letter.
